- Officer: Haire

- Cherry Blossom Lane No suspicious activity observed.
- Park Area walk-through No foot traffic
- Citrus Grove Rd Foot Path No foot traffic observed.
- Pineapple Grove Rd Foot Path No foot traffic observed.
- Gazebo- Nothing suspicious observed

#### Old Business:

- Light reported near 12006 Cherry Blossom Lane not working
  - Light is operational contractor also took care of second light in same area.
- Tree removal
  - Owners of 15605/15607 requested the three additional trees be removed and replaced with new trees. There is a strip of land that is HOA owned between the two houses and the trees were planted originally by the HOA.
  - FYI If there's 16 feet from strip to house, then the tree on strip is owned by county. If less than 16 feet, then it's the homeowner's property.
  - A tree and two smaller stumps were removed at the end of the street of Cherry Blossom court.
  - Tree and stump in common area of Garage townhouses to be removed, trimmed and replaced

- Potomac Garden Center
  - A PGC committee was formed (David Haas, Richard Schinner, and anyone else interested should contact David, Richard, or Steve)
  - Committee will meet with David Gardner and decide next steps
- Ramp in lower townhome
  - Steve will to talk to David Gardner again to get his opinion on next steps.

#### **New Business:**

- Confusion from today's Metropolis emails: apologies
  - Townhouse Parking We have signed an agreement with Henry's Towing
  - The signs were put in allowing for towing now.
  - In-person meetings need to get more people together to help build community
- <u>Gazabo</u>
  - Light has been reported out again
- Approval to order Reserve Study
  - Board will vote on this
- Board and Collection Services
  - We have identified several (~4) accounts to be handed over to Gardner for collections. (Michelle from Metropolis to connect with Gardner on these)
- Draft Budget
  - Planned for a break even budget
  - Currently awaiting contract for trash (budgeting \$15k)
  - No new assessments
  - Mostly kept everything the same as last year's budget except for:
    - Increasing legal to \$7500 because of some outstanding issues
    - Small (5%) increase for common area/landscaping maintenance (budgeting for contract renewal in 2025)
      - Will get estimates from Community and from Carlos to determine who to continue with next year
