### - Projects for Summer 2025:

- Retaining wall near entrance to main park off of Blackberry Dr.
- Planting of trees (SFH- one tree on Blackberry drive, before you reach Terrace, One tree in the townhomes.) County maintains the trees that are on blackberry drive through Citrus.
- Request to trim trees behind 15601 Gooseberry Ct trees leaning towards house- Estimate for cost pending.
- 15711 Cherry Blossom Lane- requested branches be trimmed- seeking quote- will be part of summer projects

#### **New Business:**

- Board to meet with Metropolis and review CCOC compliance
- Paint colors- ARC is transitioning to white for trims, bannisters etc.. The cream colors are outdated. New windows that are coming in you can't get "off white" without an upcharge. Avoid mismatching white and off-white. Bylaws have the 'off white". That color is outdated and expensive. Many members are using white. HOA will vote to occur in December 2025 Annual meeting.
- Townhome Parking- Homeowners who observe chronically improperly parked cars should email the board so we can assess the situation and take next steps. Red signs will now be placed on cars that are improperly parked per HOA guidelines. They will have 24 hours to move the car otherwise the cars will be towed.
- Sprinkler system- status of account, confirm where the bill will go- Steve to follow up (Action: Mark Taber can re-reach out to WSSC to get details)
- **HOA fees discrepancy between Website and Metropolis-** Steve corrected it on the website
- Issue: New trees are not being re-planted after tree removal

- **Action**: Mark Taber will email Jen G. a list of addresses where there were trees/bushes removed with no replantings. Jen will then send notifications.
- Mosquito Joe Treatment- started in May- will come through every 3 weeks;
   Steve will ask about putting up signs for where they've sprayed so we know what areas are treated
