### **DOG LICENSE**



All dogs in the Town need to be licensed and must have proof of rabies for license. Fees are as follows: spayed/neutered - \$7.00; not spayed/neutered - \$12.00. License can be applied for when paying taxes or by mail. A self-addressed, stamped envelope is needed if you want your tags sent in mail. All current dog licenses expire at the end of the year.
