Town of Kaukauna Annual Meeting Minutes April 16, 2024

Meeting was called to order at 6:30 p.m. by Chairman Van Asten. Pledge of Allegiance was recited.

Present were, Chairman Mike Van Asten, Supervisor Dennis Van Vreede, Supervisor Mike Van Vreede, and Debbie Vander Heiden Clerk/Treasurer. Also present were 15 residents and 4 Guest.

Motion to approve the minutes of the April 18, 2023 Annual meeting as presented. Motion by Bob Fox to approve the minutes as presented, second by Bernie Vander Heiden. Motion carried. 15 aye, 0 nay.

Legal Discussion. There were no legal issues.

Annual Report:

The Annual Report was presented by Clerk Vander Heiden. Motion by Pat Van De Hey to accept the report as presented, second by Bernie Vander Heiden. Motion carried 15 aye 0 nay.

Fire Department report:

The Fire Department report was given by Chief Shaun Simon. Shaun reported that they had 41 calls in 2023, down from 54 in 2022 which 15 were car fires, 2 structure fires and the rest being accidents, most from Highway 41. They have 28 active members with 4 new members training. They are still looking for new members as they had a few more retire. They will be purchasing a new truck at a cost of about 800,000.00. They thanked the Town for supporting this purchase.

EMR Report:

Shane Robley reported that they presently have 14 members on the department with 4 new members training so they are back to their roster. He reported that Sue Nackers retired and thanked her for her 30 years of service. They had 98 calls in 2023 mostly medical as they had fewer accidents.

Historical Society report:

The new members Neil Geiger, Joe and Kathy De Bruin were present to report that they just had the old school house painted and are thankful to the Town of Kaukauna to let them use their facility for events They have an event coming up on May 11th to celebrate 40 years for the Historical Society forming their organization. They are seeking donation to put a storage shed out back.

Open Discussion:

• Residents were questioning when Farrell Road is going to be fixed. Chairman Van Asten reported that because of limited funds they can only do a mile at a time. They are hoping to do County Road JJ to Hasselt road this year. The Bridge on the north end of Farell will be replaced in 2025. A resident questioned why they cut down all the trees in the ditches. Chairman Van Asten reported that he asked the person that does our ditch cutting to clean it up because they were getting over grown.

New Business:
