A 50% deposit and signed contract is required to secure the reservation.

The balance is due in full 14 days prior to the function date, at which date the final number of guests must be confirmed.

The client shall be responsible for any breakages, damages, shortages during the event.

A breakage fee of R5000 will be added to your invoice and will be fully/partially refunded depending on any breakages or damages caused to the venue by any member of the wedding party. The amount will be refunded back into the bank account supplied by the wedding couple 7 days after the function.

**Please NOTE an additional charge of R1000 per hour will be charged for the use of any of the Hall facilities after 24h00.**

If paying via EFT, any bank charges incurred are at the expense of the client.

**NO SELF CATERING.** Our Wedding coordinator will provide a list of recommended caterers.

We kindly request that only fresh or dried flowers / leaves be used as confetti as we are a nature conservation area.

**Picking flowers and greenery on the mountain is STRICTLY PROHIBITED.**

Should a radical shift in weather affect the arrangement of the function, the client remains responsible for any extra costs.

**Heaven's View Mountain Resort is an uneven terrain as we are situated on a mountain. This may pose danger for guests and parents must accompany their children at all times and take full responsibility for their safety.**
