A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE HON. ROSELLER G. CARATIHAN TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH CARESPAN ASIA INC. REPRESENTED BY ITS PRESIDENT AND CHIEF EXECUTIVE OFFICER (CEO) MR. RAYMOND VIDAL MARAÑON, FOR THE IMPLEMENTATION OF THE PHILHEALTH YAKAP (YAMAN NG KALUSUGAN) PROGRAM WITHIN THE MUNICIPALITY OF CALAUAN, LAGUNA.

WHEREAS, the 1987 Philippine Constitution declares it a policy of the State to protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Republic Act No. 11223, otherwise known as the Universal Health Care (UHC) Act, mandates the integration of health services and the expansion of primary care benefits through PhilHealth;

WHEREAS, the PhilHealth YAKAP (Yaman ng Kalusugan) Program is a strategic initiative designed to provide comprehensive primary care, including consultations, laboratory tests, and medicines, specifically targeting marginalized and underserved sectors;

WHEREAS, CareSpan Asia Inc. is engaged in the business of developing, designing and managing a fully integrated digital network, which includes a mobile healthcare application or digital platform accredited by Philhealth for YAKAP Administration, for the personal management of health and well-being;

WHEREAS, the Bids and Awards Committee Resolution No. 13-s-2026 declared Carespan Asia Inc. as the bidder with the Single or Lowest Calculated and Responsive Bid for PhilHealth YAKAP Benefit Package "Performance-Based Payment" consisting of Four Hundred Eighty Pesos (₱ 480.00) for the registration of eligible beneficiaries with First Patient Encounter (FPE) and Two

Hundred Pesos (₱ 200.00) after providing medical consultations/laboratory test/administration of medicines and achieved performance targets at the end of the year.

WHEREAS, pursuant to Section 444 (b)(1)(vi) of the Local Government Code of 1991, the Municipal Mayor shall represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, upon authorization by the Sangguniang Bayan;

NOW THEREFORE, upon motion of **HON. ALLAN ANTONIO V. SANCHEZ II** duly seconded by **HON. KENNETH B. KRAFT** and unanimously approved by the members of the Sangguniang Bayan, it was;


RESOLVED FURTHER, that a copy of the signed Memorandum of Agreement shall form an integral part of this Resolution.


