A RESOLUTION ADOPTING AND APPROVING MUNICIPAL DEVELOPMENT COUNCIL EXECUTIVE COMMITTEE RESOLUTION NO. 03-2026, ENTITLED: "RESOLUTION APPROVING THE SUPPLEMENTAL LOCAL DEVELOPMENT INVESTMENT PROGRAM (SLDIP) AND THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) IN THE AMOUNT OF FIVE MILLION PESOS (PHP 5,000,000.00), FUNDED UNDER THE LOCAL GOVERNMENT SUPPORT FUND-FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF-FALGU) PURSUANT TO THE FY 2026 GENERAL APPROPRIATIONS ACT, REPUBLIC ACT NO. 12314 FOR THE IMPLEMENTATION OF THE ASSISTANCE TO INDIGENT INDIVIDUALS OR FAMILIES- FOOD ASSISTANCE/RICE DISTRIBUTION PROJECT, AND ENDORSING THE SAME TO THE SANGGUNIANG BAYAN FOR APPROVAL."

WHEREAS, the Department of Budget and Management (DBM) and the Department of the Interior and Local Government (DILG) issued Joint Circular No. 1, s. 2026, on February 19, 2026, which stipulates the guidelines on the utilization of funds for the implementation of the Assistance to Indigent Individuals or Families (AIIF) - Food Assistance/Rice Distribution Project;

WHEREAS, the LGSF-FALGU funds are dedicated for the implementation of the Assistance to Indigent Individuals or Families -Food Assistance/Rice Distribution Project aimed to provide immediate social protection and food security to its most vulnerable residents, particularly indigent families;

WHEREAS, the Sangguniang Bayan has reviewed the said MDC resolution and found the same to be in order and beneficial to the general welfare of the municipality;

NOW THEREFORE, on motion of **HON. DANTE C. ESCAREZ** , duly seconded and unanimously approved by all of the Members of the Sangguniang Bayan present during this special session, it was:




