WHEREAS, the Office of the Secretary of the Sangguniang Bayan received measure entitled "Rebisyon ng Kautusang Pambarangay ukol sa buwis bilang 04-2-2025" and the same was referred to the Committee on Finance, Appropriation, Ways and Means which conducted its committee meeting and rendered committee report which was adopted and carried by the August Body;

WHEREAS, the Sangguniang Bayan has the power and authority under the Local Government Code of 1991 to exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare of its inhabitants;

WHEREAS, the review and the evaluation process confirmed that the enactment of the said ordinance is within the power of the Sangguniang Barangay concerned as provided under R.A. 7160 otherwise known as the Local Government Code of 1991, particularly Section 187 and Section 152 thereof;

WHEREAS, the said committee recommends to declare Kapasiyahan blg. 02-s-2025 entitled, "Rebisyon ng Kautusang Pambarangay ukol sa buwis bilang 04-2-2025 ng Barangay Silangan, Calauan, Laguna.", as consistent with law;
