RESOLUTION APPROVING RESOLUTION NO. 16 SERIES OF 2025 OF THE SANGGUNIANG KABATAAN OF BARANGAY HANGGAN, CALAUAN, LAGUNA "A RESOLUTION APPROVING THE COMPREHENSIVE BARANGAY YOUTH DEVELOPMENT PLAN OF SANGGUNIANG KABATAAN OF BARANGAY HANGGAN, CALAUAN, LAGUNA FOR FISCAL YEAR 2026-2028."

WHEREAS, Republic Act No. 10742, otherwise known as the *Sangguniang Kabataan Reform Act of 2015*, mandates the formulation of a Comprehensive Barangay Youth Development Plan to serve as the blueprint for all youth-related programs, projects, and activities in the barangay;

WHEREAS, the Sangguniang Kabataan, in consultation with the Katipunan ng Kabataan, shall formulate a 3-year rolling plan, which shall be known as the Comprehensive Barangay Youth Development Plan (CBYDP). This plan shall be aligned with the Philippine Youth Development Plan and Local Youth Development Plans in the Provincial, City, or Municipal level;

WHEREAS, The CBYDP shall serve as the basis for the preparation of the Annual Barangay Youth Investment Program (ABYIP);

WHEREAS, the Sangguniang Kabataan of Barangay Hanggan, submitted to this office their Comprehensive Barangay Youth Development Plan (CBYDP) for CY 2026-2028 which was approved under SK Resolution No. 16, s, 2025;

WHEREAS, the joint Committee on Finance, Appropriations, Ways and Means and Committee on Youth Development thoroughly discussed and reviewed the Comprehensive Barangay Youth Development Plan (CBYDP) for CY 2026-2028 of the Sangguniang Kabataan of Barangay Hanggan, and concluded that the programs and projects are attainable and consistent with the youth development and empowerment programs, projects and activities in accordance with the Philippine Youth Development Plan and Local Youth Development Plan;

NOW THEREFORE, upon motion of **HON. OLYMPIO S. AMANTE**, duly seconded by **HON. JOAN PAMELA M. BABATID** and unanimously approved by the members of the Sangguniang Bayan, it was;


