AN ORDINANCE GRANTING CASH INCENTIVES TO CHAMPION ATHLETES AND COACHES OF THE MUNICIPALITY OF CALAUAN IN PROVINCIAL, REGIONAL, NATIONAL AND INTERNATIONAL COMPETITIONS IN ALL LEVELS AND APPROPRIATING FUNDS THEREOF.

WHEREAS, Article II, Section 17 of the 1987 Philippine Constitution provides that "the State shall give priority to education, science and technology, arts, culture and sports to foster patriotism and nationalism accelerate social progress, and promote total human liberation and development;

WHEREAS, Article XIV, Section 19 (1) of the same fundamental law further provides that "The State shall promote physical education and encourage sports programs, league competitions and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry;

WHEREAS, for bringing honor and prestige to the name of the Municipality of Calauan, the Local Government Unit of Calauan deems it right to provide due compensation in the form of cash incentives to all deserving athletes and coaches;

NOW THEREFORE, upon motion of **HON. ALLAN ANTONIO V. SANCHEZ II** duly seconded by **HON. JUNE JOSEPH F. BRION** and unanimously approved by the members of the Sangguniang Bayan present;

Be it ordained by the Sangguniang Bayan of Calauan, Laguna, in a session duly assembled to enact.

SECTION 1. TITLE. This Ordinance shall be known as, "Calauan Sports Incentive Program".

SECTION 2. SCOPE AND COVERAGE. The athletes, coaches/assistant coaches who may be entitled to the incentive granted by this Ordinance shall be those who have landed as Champion in their respective levels of Sports Competition.

SECTION 3. DECLARATION OF PURPOSE. It is hereby declared a policy of the Municipality of Calauan to extend financial incentives to deserving athletes and coaches/assistant coaches for having given honor to the Municipality in various legitimate competitions in the fields of sports competitions.

SECTION 4. DEFINITION OF WORDS AND PHRASES. For the purpose of this ordinance, the terms hereunder mentioned shall be defined as follows:

- a. Sports Competitions – refer to various sports competitions that are accredited or sanctioned by the following government agencies:
 - Department of Education (DepEd)
 - Philippine Olympic Committee (POC)
 - Philippine Sports Commission (PSC)
 - Department of Interior and Local Government (DILG)
 - Commission on Higher Education (CHED)
 - Higher Education Institution (HEI)
- b. Sports competitions may be categorized as:
 - i. National Sports Competition include, but not limited to the following:
 - Palarong Pambansa
 - Private Schools Athlete Association (PRISAA)
 - State College Universities Athletic Association (SCUAA)
 - University Athletic Association of the Philippines (UAAP)
 - National College Athletic Association of the Philippines (NCAA)
 - Philippine National Youth Games (Batang Pinoy)
 - National Open
 - National Games
 - Special Olympics
 - c. For International and Worldwide levels of Sports Competition include regular sports competitions sanctioned by the International Olympic Committee and/or the International Sports Federation such as:
 - Summer Olympics
 - World Championship of respective sports
 - Asian Games
 - Asian Championship of respective sports
 - South East Asia Games (SEA Games)
 - ASEAN Championships of respective sports
 - Special Olympics

*Sports competitions would not include exhibition games.

SECTION 5. QUALIFICATION OF GRANTEES. To qualify as a grantee, he/she must:

- a. Athlete – be a bona-fide resident of the Municipality of Calauan and must have duly represented the Municipality of Calauan in the competitions she/he had participated.
- b. Have informed the Municipal Sports Incentive Committee through writing of his/her participation and that she/he is an official representative of the Municipality, Province, Region and/or the country in a particular competition before the actual competition for records purposes.
- c. Be able to submit original and/or certified true copy of certification and appropriate documentations that she/he participated and won accordingly in a duly accredited sports competition in the provincial, regional, national, international and worldwide levels.
- d. For coach/assistant coach:
 - i. Be a bona-fide resident of the Municipality of Calauan and/or has been assigned as the official coach/assistant coach of the Champion Team of the Municipality and;
 - ii. Must have duly represented the Municipality of Calauan in the competitions.

SECTION 6. AMOUNT OF INCENTIVES FOR ATHLETES

- a. For Champion individual sports competitions for the provincial, regional, national and international levels of competitions, qualified grantees shall be entitled to receive the following incentives:
 - Provincial Level – Php 1,000.00
 - Regional Level – Php 1,500.00
 - National Level – Php 2,000.00
 - International Level – Php 3,000.00
- b. For Champion paired or group sports competitions, grantees shall be entitled to receive the following incentives for the whole group:
 - Provincial Level – Php 3,000.00
 - Regional Level – Php 5,000.00
 - National Level – Php 7,000.00
 - International Level – Php 10,000.00

SECTION 7. AMOUNT OF INCENTIVES FOR COACH/ASSISTANT COACH

- a. For Champion individual sports competitions for the provincial, regional, national and international levels of competitions, qualified grantees shall be entitled to receive the following cash incentives:
 - Provincial Level – Php 1,000.00
 - Regional Level – Php 1,500.00
 - National Level – Php 2,000.00
 - International Level – Php 3,000.00
- b. For Champion paired or group sports competitions, grantees shall be entitled to receive the following incentives for the whole group:
 - Provincial Level – Php 2,000.00
 - Regional Level – Php 3,000.00
 - National Level – Php 4,000.00
 - International Level – Php 5,000.00

c. Coached for regular athletes in team sports (*only one (1) coach per event will be recognized for the purpose of this ordinance for team events:*

- Provincial Level – Php 1,000.00
- Regional Level – Php 2,000.00
- National Level – Php 3,000.00
- International Level – Php 5,000.00

d. Individual Sports for athletes who are Persons with Disabilities:

- Provincial Level – Php 2,000.00
- Regional Level – Php 3,000.00
- National Level – Php 5,000.00
- International Level – -Php 10,000.00

e. Coaches on individual sports for athletes who are Persons with Disabilities:

- Provincial Level – Php 2,000.00
- Regional Level – Php 3,000.00
- National Level – Php 5,000.00
- International Level – Php 10,000.00

f. Athletes in team sports under Persons with Disabilities (*each member will receive*)

- Provincial Level – Php 1,000.00
- Regional Level – Php 2,000.00
- National Level – Php 5,000.00
- International Level – Php 10,000.00

g. Coaches in team sports under Persons with Disabilities (*only one (1) coach per event will be recognized for the purpose of this ordinance for team events*)

- Provincial Level – Php 1,000.00
- Regional Level – Php 2,000.00
- National Level – Php 3,000.00
- International Level – Php 5,000.00

SECTION 8. MUNICIPAL SPORTS INCENTIVE COMMITTEE. The Municipal Sports Incentive Committee is hereby created, which is primarily tasked to judiciously screen applicants based on the qualifications set forth in this ordinance and its implementing rules and regulations. The Municipal Sports Incentive Committee is composed of the following:

Chairman:	Municipal Mayor
Vice-Chairman:	Municipal Vice-Mayor
Members:	Local Youth Development Officer
	Municipal Social Welfare Officer
	SK Federation President
	SB Member (Chairman of the Committee on Education)

SECTION 9. IMPLEMENTING AGENCIES:

- Office of the Municipal Mayor
- Local Youth Development Office
- Treasury Office

SECTION 10. MANDATORY FUNDING REQUIREMENT. To carry out the provisions of this ordinance, the amount of THREE HUNDRED THOUSAND PESOS (P300,000.00) shall be appropriated from the General Fund of the Municipality.

SECTION 11. SEPERABILITY CLAUSE. If, for any reasons, any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect

SECTION 12. REPEALING CLAUSE. All ordinances, as well as pertinent rules and regulations thereof, which are inconsistent with the provisions of this Ordinance are hereby repealed or amended accordingly.

SECTION 13. EFFECTIVITY. This Ordinance shall take effect upon approval and compliance of the necessary requirements set by law.

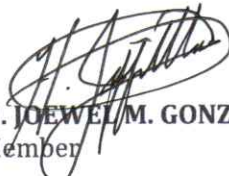

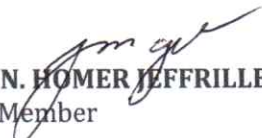

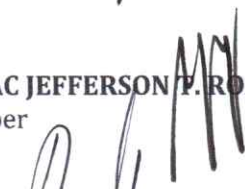
