AN ORDINANCE RENAMING DAYAP NATIONAL INTEGRATED HIGHSCHOOL TO CALAUAN NATIONAL HIGH SCHOOL AND SEPARATING IT FROM ITS MOTHER SCHOOL, THE DAYAP NATIONAL HIGH SCHOOL.

WHEREAS, Section 99 (d) of Republic Act 7160 authorizes the Local Sanggunian to change the name of public schools within the territorial jurisdiction of the local government unit through an ordinance upon the recommendation of the Local School Board;

WHEREAS, the Department of Education through DepEd Order No. 40.s. 2014 entitled "Establishment, Merging, Conversion and Naming/Renaming of the Public Schools and Separation of Public Schools Annexes in Basic Education" requires a Sangguniang Bayan resolution supporting the separation and renaming of a school before it gives recognition to an independent public education institution;

WHEREAS, the Local School Board through Resolution No. 4 s. 2025 recommended the renaming of Dayap National Integrated High School to Calauan National High School located at Barangay Masiit, Calauan, Laguna;

WHEREAS, the Sangguniang Bayan also supports the separation of Calauan National High School from its mother school the Dayap National High School;

NOW THEREFORE, upon motion of HON. JOSELITO M. MANALO, duly seconded by HON. KENNETH B. KRAFT and approved by all the members of the Sangguniang Bayan;

Be it ordained by the Sangguniang Bayan of Calauan, Laguna in session assembled that:

MUN. ORDINANCE NO. 03-12-2025

SECTION I. TITLE. This Ordinance shall be known as "An Ordinance renaming Dayap National Integrated High School to Calauan National High School".

SECTION II. PURPOSE. This ordinance is enacted in cognizance of the recommendation of the Local School Board of Calauan, Laguna through its Resolution No. 4 s. 2025 to rename Dayap National Integrated High School to Calauan National High School and its separation from its Mother School.

SECTION 3. LEGAL BASIS.

- a. Section 99 (d) of Republic Act 7160 authorizes the Local Sanggunian to change the name of public schools within the territorial jurisdiction of the local government unit through an ordinance upon the recommendation of the Local School Board.
- b. Department of Education Order No. 40 s. 2014 Establishment, Merging, Conversion and Naming/Renaming of the Public Schools and Separation of Public School Annexes in Basic Education.
- c. Local School Board of Calauan Resolution No. 04 s-2025

SECTION 4. DECLARATION. The Dayap National Integrated High School is hereby renamed as Calauan National High School thereby separating it from its mother school, Dayap National Highschool.

SECTION 5. REPEALING CLAUSE. Municipal Ordinance No. 10-14-2020 entitled "An ordinance renaming Dayap National Integrated High School to Calauan Integrated National High School" is hereby repealed.

SECTION 6. EFFECTIVITY. This ordinance shall take effect upon approval.
