Treasurer's Report

- Regular account balance as of November 1, 2016 is \$15,553.08 with \$2,152.05 in Capital Improvement account for a total balance of \$17,705.13.
- Dead trees in the common area behind Juanita Budde's house were removed at a cost of \$1,700. They were in danger of falling and damaging Juanita's home and were also a danger to anyone walking in the park area.
- The budget was proposed to stay the same, with no changes. Motion to approve was made by Brian Macaluso and seconded by Dede Ricard.
