# **Revised Covenants**



# Your Board is attempting one last meeting this year to get enough votes (52 are needed) to decide whether we approve the revised covenants or keep them as is. An additional change, recommended at the last meeting, has been made to Section 4.4. and is highlighted below. <u>The verbiage is identical to existing covenants WITHOUT the highlighted text.</u>

Needed Grounds and Facility Maintenance: Should

any property owner fail to properly maintain their property or in any manner, allow its property to become detrimental to the aesthetic scheme of the subdivision, or violates these restrictions in any manner, then the Association, its agent, employee, and/or contractors shall have the right to enter upon the property in order to take such corrective actions as will alleviate the situation. This would only be necessary in the event the property is uninhabited.

The meeting is scheduled for Saturday, December 5, 2020 at 10:00 am in the linear park. A proxy will be sent to all lot owners for you to make your vote known, if you cannot attend the meeting, by returning it to a Board member or other neighbor who will attend. (If you can attend, a proxy is not needed.) It is CRITICAL for us to have enough votes to resolve this issue. If you have any questions about the revisions or current covenants, please contact any Board member. Current covenants are on our website.

The revised covenants will be emailed to all lot owners and hand-delivered to all residents by November 25, 2020.
