THE DRIVERS SEAT LLC will provide Segment 1 Driver Education at a fee of \$450.00. A non-refundable \$150.00 fee enrolls the student and is required at the time of registration you select the payment plan. The remaining balance is to be paid in full by the 12th day of class and is nonrefundable. Tuition may be paid electronically via the website at www.thedriversseat2.com. THE DRIVERS SEAT will provide a minimum of 24 hours of classroom instruction, 6 hours of behind the wheel instruction (BTW) and 4 hours of observation time. There is a \$20.00 fee for all scheduled drive sessions that a student does not attend or cancel at least 2 hours in advance. THE DRIVERS SEAT LLC will conduct the behind-the wheel instruction in a dual controlled automobile that is fully insured, covering each student enrolled in the program. Classroom instruction must be a minimum of 3 weeks in length. BTW instruction shall not begin until the student has received a minimum of 4 hours of classroom instruction; BTW instruction must be completed no later than 3 weeks after classroom. There may be up to three students in the driver education vehicle whenever behind the wheel instruction is provided. Students must complete all 12 days of class instruction and 24 hours of drive/observation and pass the required State test at 70% accuracy in order to receive a certificate of completion. Students will be given up to two additional attempts to pass the test. A student may only miss one day of class with a reasonable excuse (i.e. illness, family matter) which must be made up at the end of the class or in a future Segment 1 class. I understand that my son/daughter must still complete at least 4 hours of observation time as a passenger in a driver education vehicle being driven by another driver education student.

Students will be required to be visible during the entire length of class. Student attendance will be monitored constantly throughout the class session and attendance taken at the beginning of the class, end of the class, and after any breaks. Any student missing at any attendance taken during class or during any observation by the instructor or proctor shall not receive credit for the class.

Students will be required to limit distractions to actively participate in class. If an instructor or proctor observes a student engaging in activity unrelated to the classroom, then the student will be given a verbal warning. Upon a second occurrence of unrelated activity during a class session, the instructor will terminate the student from the class. The student shall not receive credit for the class.

Failure to show up for class or logging in 15 minutes or more late will result in the student being required to make up the class day at the rate of \$30 per class day. Two or more absences or late logins will result in the student being dropped from the class and being required to come back to the next available class.

All classes will be recorded and made available to MDOS upon request.
