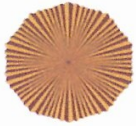

Elements of the emblem



The rays of the sun

The rays of the sun form the background of our proud emblem and suggests the Legion's principles will dispel the darkness of violence and evil.



The wreath

The wreath forms the center, in loving memory of those brave comrades who gave their lives in the service of the United States that liberty might endure.



The star

The star, victory symbol of World War I, also symbolizes honor, glory and constancy. The letters "U.S." leave no doubt as to the brightest star in the Legion's star.



Outer rings

The larger of two outer rings stands for the rehabilitation of our sick and disabled comrades. The smaller inside ring denotes the welfare of America's children.



Inner rings

The smaller of two inner rings set upon the star represents service to our communities, states and the nation. The larger outer ring pledges loyalty to Americanism.

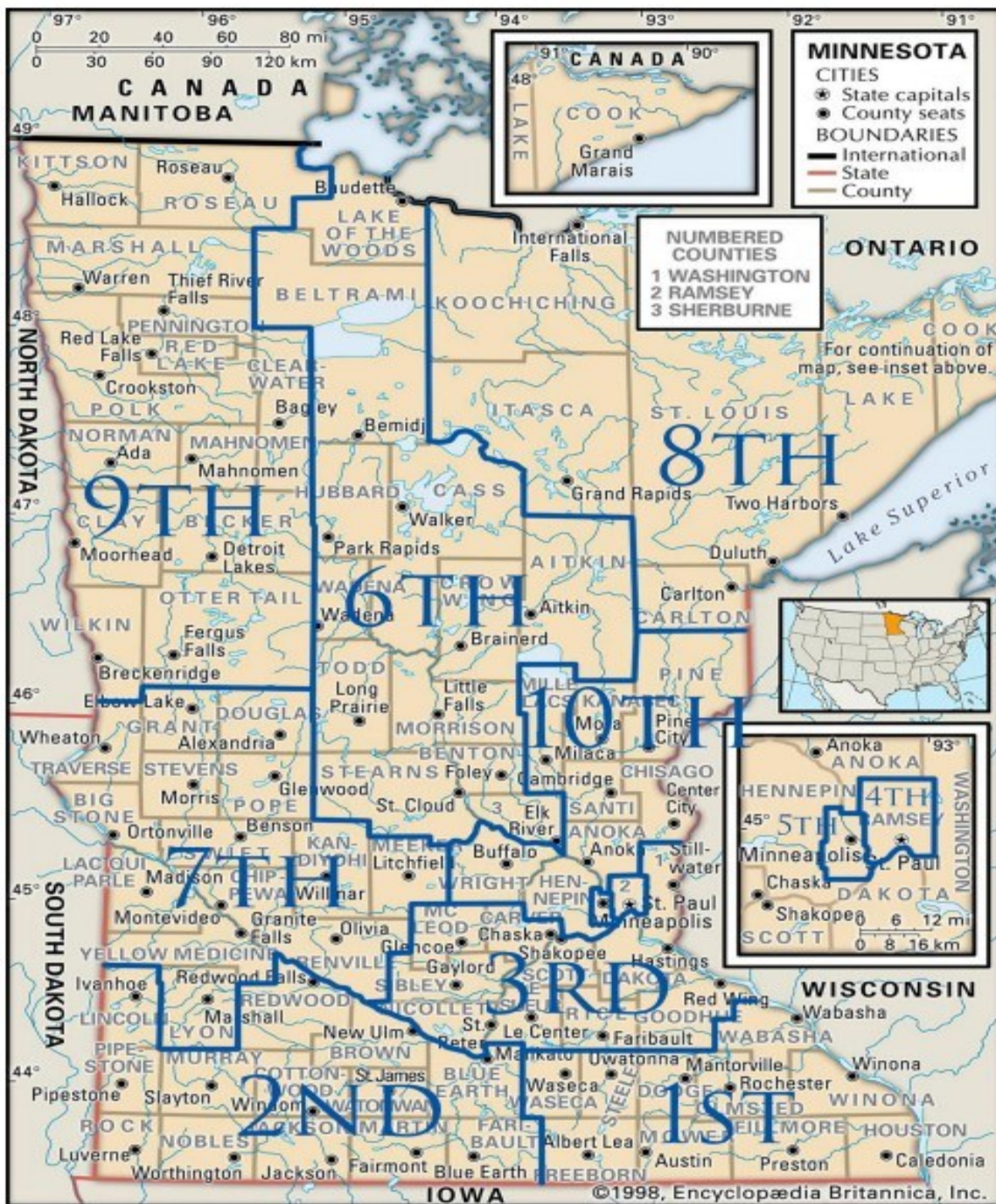

Consolidated Post Report

I have been asked by Commander Dvorak if I would oversee the CPR's again this year. Last year was the first time ever that Minnesota got recognized on stage at National Convention. That happened largely because of the help of a select few members. It should have to come down to that. Every Post and I do mean every Post has something they do that is on that report. If you look at the form you will see line 125 which states any funds raised not on report. Well that is fillable because 25 cents of our dues goes to Hospital Association. Take the number of members times 4 (rounding up to nearest dollar) 126 is fillable because you took the time to fill out line 125. There again you have to round up to the nearest hour.

Your post should have received a hard copy. It is also accessible on line at myl-region.org. If you use the hard copy send that form to me. Either thru post office or email.

This is one thing that is doable by EVERY post. Do not ignore. This data is used by our National Commander when he speaks in front of Congress letting them know what it is we do.

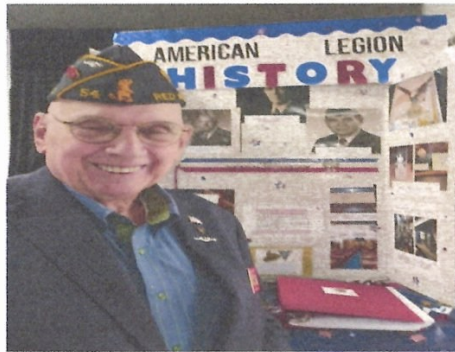

Conduct such other business as may be brought before the Convention in conformity with the provisions of the Department and National Constitutions.

District Chairmen

All District Chairmen must file/type a report for the District Book of Annual Reports, which will be distributed at the Convention. Reports should include information from the Unit annual reports forwarded to each respective Chairman by the Department office shortly after April 15 and any pertinent information regarding District projects or activities in your program area. Reports should be forwarded to the First District President **No later than April 15, 2026**. If possible, reports should be typewritten and ready to print.

District Chairmen are also responsible to judge the Annual Reports in their respective program area for trophies, awards and certificates of merit according to the District Standing Rules. They should notify the District President of winners of Certificates of merit prior to the opening of the Convention so that the certificates can be properly prepared, signed and awarded at the Convention.

Unit Color Bearers

Units are encouraged to bring their flags to the Convention to be presented as part of the opening ceremonies, posted during the Auxiliary sessions, and retired at the close of the convention. Auxiliary members who are carrying in their flags at the District Convention are asked to meet at the session meeting room at 8:00 am on Saturday, May 17, 2025, to rehearse.

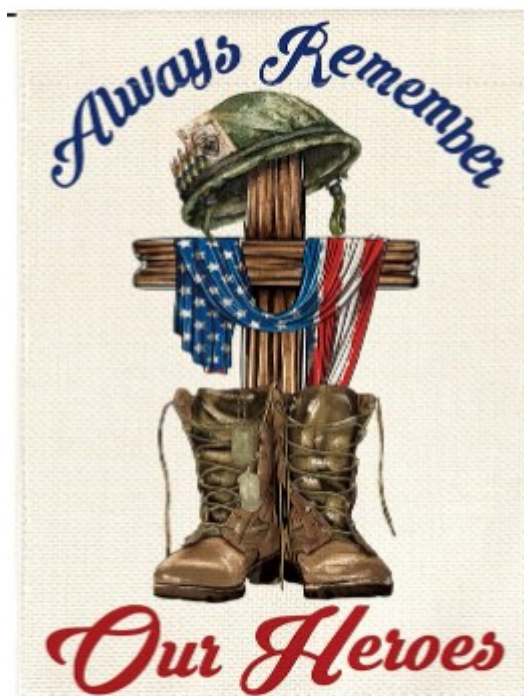

As I compile this newsletter District 1 slipped from 3rd place to 4th place out of 10. From a percentage stand point we increased 4.6 percent.

IMPORTANT INFORMATION TO UNDERSTAND REGARDING RENEWAL STATUS AND DATE

Membership Renewal Dates

The SAL membership year follows the calendar year (Jan 1 through Dec 31) and renewals due in advance, meaning 2026 renewals were due by Dec 31, 2025. Ideally, they should be submitted by about mid-December so National has time to process them before Jan 1. Here are the important renewal dates from the National SAL Bylaws:

Any member whose renewal has not been processed at National by **Jan 1** goes into **delinquent** status. If the member renews before Feb 1, they are automatically returned to “active in good standing”.

Any member who is still delinquent on **Feb 1** goes into **suspended** status. A member in suspended status loses all privileges and benefits of membership until reinstated. That includes the ability to hold any office, the ability to vote, the ability to represent their squadron as a delegate at District and/or Detachment convention, and in Minnesota, the benefit of the Minnesota American Legion Family Hospital Association. On **June 1**, suspended memberships are **forfeited** and no further renewal notices are sent.

A suspended/forfeited member can be reinstated to “active in good standing” by a motion brought before the squadron membership body to approve the reinstatement and upon payment of dues for the current year (though I suspect most squadrons forego the formality of actually voting the member back in). This is not spelled out, but my understanding is, as long as the member is reinstated in the same year their membership was forfeited, they do not lose their continuous years. For example, if you have any members who have not paid their 2026 dues, they would need to be reinstated before the end of the year to keep their continuous years.

Please take immediate action and review how many of your members from 2025 have not yet renewed their membership and take action now!

Growing a Strong SAL Squadron: Proven Strategies for Recruitment, Renewal, and Engagement

Many successful Sons of the American Legion (SAL) squadrons grow quickly by combining targeted recruiting with meaningful, visible activities and consistent follow-up on renewals. The most effective squadrons don't wait for members to come to them—they build a welcoming, active presence that families want to be part of.

1. Focused Recruiting Instead of “Waiting for Them”

- Set clear, short-term goals such as “+10 new members by July 1,” and review progress at each meeting.
- Ask Legionnaires and Auxiliary members to identify sons, grandsons, and great-grandsons who are eligible. A personal invitation to these family members—your “family tree” approach—is one of the fastest ways to grow.

Be present where eligible families already gather: youth sports, school events, Scout meetings, church, and community activities. Keep simple sign-up or interest forms ready.

2. Activities That Attract Families

- Host youth-friendly events under the SAL name—flag retirements, youth shooting or marksmanship clubs, fishing derbies, car washes, or sports tournaments. These naturally bring in parents and grandparents who may also be eligible for SAL or other Legion Family programs.
- Partner with schools and youth groups for flag education, essay contests, or service days. Positive, visible involvement often leads to new memberships from families who appreciate the mission.

Connect recruiting to high-traffic post events such as fish fries, raffles, benefit dinners, or golf outings. Always have SAL applications and someone ready to explain eligibility and dues.

3. Make Joining and Renewing Easy

- Offer on-the-spot sign-ups with dues collection at events. When possible, provide online or QR-code access to membership forms so families can join from their phones.
- Send short, friendly reminders—letters, emails, texts, or calls—to encourage renewals before deadlines. Posts that mail renewal letters with a stamped return envelope see faster and higher response rates.

Maintain a simple contact list with each member's preferred communication method and schedule renewal reminders for December and January to avoid last-minute scrambling.

4. Give Members Something Meaningful to Do

- New members stay—and bring friends—when they are invited to help with real, mission-centered tasks such as serving at VA dinners, working fundraisers, or assisting with ceremonies.
- Ask each member what they enjoy or excel at (cooking, carpentry, social media, organizing, public speaking) and match them with tasks quickly so they feel valued and needed.

Recognize contributions publicly at meetings, on social media, and in newsletters. Visible appreciation encourages continued involvement and inspires members to recruit others.

5. Strengthen Visibility and Communication

- Keep SAL activities visible by posting photos and short write-ups on the post bulletin board, website, Facebook page, and community pages. Visibility shows that the squadron is active, welcoming, and making a difference.
- Assign a tech-savvy member—often a younger SAL member—to manage social media. Squadrons that refresh their online presence often gain attention from families who didn't realize what the Legion Family offers.

Coordinate with the Legion and Auxiliary so SAL is included in all family publicity. A brief SAL update at Legion and Auxiliary meetings helps build awareness and support.

6. Use Incentives and Recognition to Encourage Growth

- Run short-term membership drives with simple rewards such as a special SAL shirt, hat, or pin for members who recruit a set number of new members.
- Create friendly competitions—“Who can bring in the most new or renewed members by May 1?”—and recognize winners at a post event.

Take advantage of department or national SAL recognition programs that reward squadrons reaching 100–105% membership by specific dates. These benchmarks naturally motivate quicker recruiting and renewals.

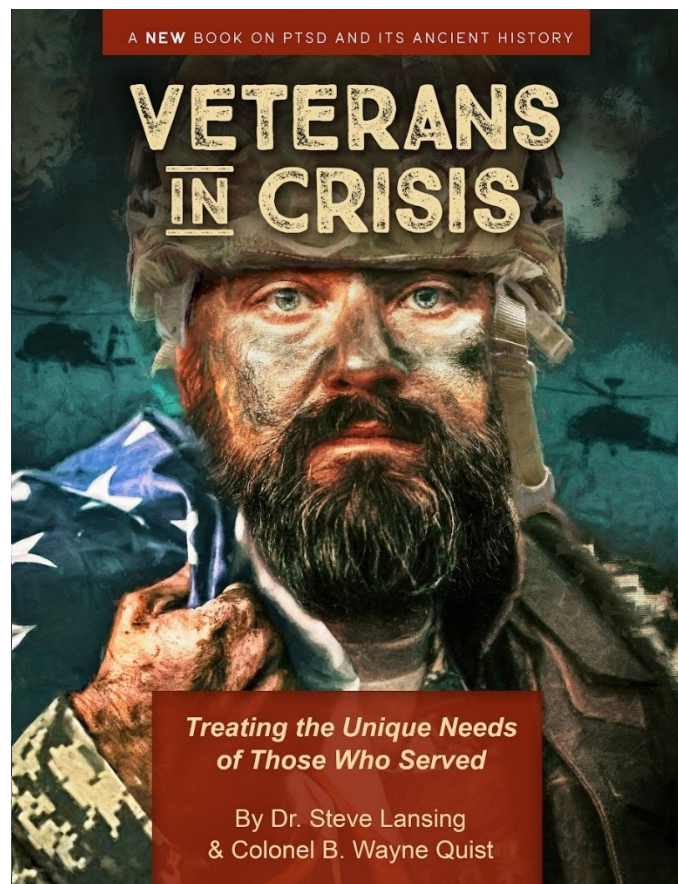
