

FROM YOUR COMMANDER

Greetings District Legion Family,

As I write this, I am left wondering where the entire month of November has gone. I hope everyone had a nice Thanksgiving. Sometimes we take things for granted, but I think there is much to be thankful for.

Personally, I am thankful for good health, the opportunities, and resources I have been blessed with, my family and friends, and of course, each of you. I am also grateful for the freedoms and liberty we enjoy, and especially those who have sacrificed much to secure those for us.

The National Judge Advocate recently published an opinion pertaining to the Sons of the American Legion based on some posts including SAL members on their post membership roster for the purposes of tax audits. While there may be some merit to that based on the applicable tax code and cited IRS guidance, I am not qualified to comment on that aspect of the Judge Advocate's position. What I can comment on is the sentiment that the SAL is just a program of the American Legion that is to be treated the same as any other youth program such as Boy's State, Legion Baseball, Oratorical, etc.

Is National stepping back from the Legion Family concept? Yes, the Sons of the American Legion is a program of the American Legion, and each SAL organization is under the direct control of the Executive Committee of the American Legion organization that sponsors it. However, we are not the youth program we were in the 1930's. We have grown and evolved. We operate under a national framework adopted by the National Executive Committee, and we have nearly 400,000 members paying dues to the National organization. Our purpose is to promote the policies and programs of the American Legion; promote patriotism and national security; and support veterans, children, and our local posts. We do this well. Among our support of Legion programs, the SAL has been the top contributor to the Legion's Child Welfare Foundation. We continually work to support veterans' affairs, children, and first responders in our communities. Our squadrons work tirelessly to support their posts, and increasingly, support from our squadrons is becoming necessary in sustaining the ongoing operation of their posts.

To imply that the Sons of the American Legion is just another Legion youth program is disingenuous at best. We continue to prove ourselves as a vital component of the Legion Family. Why should the privilege of using the Post bar or restaurant be excluded from the SAL members when, in many cases, the Post relies on the SAL to help operate those areas? If there are legal issues with this, the Legion should work through their legislative channels to correct it. This is no way implies that SAL members are members of the American Legion, it only implies that SAL members are part of the Legion Family.




