### **Admission Guidelines:**

We are willing to screen any potential resident who can verify a minimum of 30 days clean and sober and an active participation in a 12 step recovery program. We will provide a safe, secure, drug free environment that is focused on your recovery and encourages your personal growth and development.

### **First 30 days (Phase 1)**

You will be on probation for the first 30 days

Your curfew will be 10 PM for the first 30 days

You must show proof of employment

You must display willingness to be a supportive member of the house

You must be working on the completion of the 12 steps

You must supply us with your sponsor's name and phone number

There will be no overnight absences during probationary period

If you are diabetic, you must tell staff before admission to Goshen Sober Living House, if diabetic supplies are found after admission you will be asked to leave immediately.

There will be no late rent payments

You must attend 1 mandatory house meeting per week and at least 2 recovery meetings, appropriate for your addiction.

Additional rules are listed in House Rules Packet

Medical Marijuana will not be allowed, no exceptions

### **Phase 2**

After you have completed your first 30 days without complication, you will enter into phase 2. During this phase you will be expected to complete your 12 step program and to sponsor another man during his 12 step recovery.

During probation and phase 2, if there are any questions, consult your house manager and he will answer any question that you have regarding house rules. It is better to ask questions than to break the rules and ask for forgiveness.

## Goshen Sober Living House Rules

- The use of any drugs or alcohol will result in immediate discharge, any suspicion of using either; will result in a drug or alcohol test at the residence expense. **NO alcohol based mouthwash is allowed.**
- **Drug Testing:** Random drug testing will be done at staff's request, if you refuse to be tested, you will be discharged immediately. There is a 2 hour limit to submit substance for testing, after that time, it will be considered an automatic positive and you will be discharged.
- **Abuse:** Goshen Sober Living House has a zero tolerance policy for physical or verbal abuse to staff or other residents. You will be discharged immediately for this offense and the police will be called if necessary.
- **Property:** If any damages to Goshen Sober Living House occur due to your negligence or as a result of any inappropriate behavior, you will be held financially responsible for repairs and/or replacement.
- **Chores:** The chores will be split evenly between the residence, assigned by the house manager at his discretion i.e. Garbage, yard-work, house cleaning, etc..
- **Employment:** You must maintain employment during your stay at Goshen Sober Living House; you must be able to provide proof of employment upon admission. If laid off or reassigned, you have 2 weeks to find new employment, no exceptions.
- **Rent Payment:** Friday is rent day; rent will be collected by the house manager on a weekly basis. Our week runs through Saturday to Friday. If Rent is not paid on Friday, you will have until Monday to get caught up.
- Bounced checks will result in a 35.00 fee and future payments will be required in Cash or Money Order Only.
- **Gambling:** This includes playing cards for money, going to Casinos, making any kind of financial bets or buying lottery tickets, if you gamble, you will be discharged immediately.
- **Supplies:** You are responsible for providing your own food and personal items. i.e. toiletries, clothing, shoes, laundry soap etc....
- Goshen Sober Living House will supply toilet paper, paper towels and cleaning supplies for the house. You are never to take any of these items from the house, it will be considered theft.
- **Theft:** Taking something that belongs to the house or other resident without permission will result in immediate eviction.
- **Curfew:** 30 day probation 10pm, phase 2 curfew is 11pm. You must be in the house at this time, house manager must know you are in and the house will be locked.
- No person of the opposite sex is allowed in your room for any reason.
- No person under the age of 18 is allowed in the house without written staff permission ( this includes family members too)
- Family members may visit during evening hours with house managers' permission only. All guests must comply with house rules. Outside guests (other than family) must be cleared by administration.
- Out of the house, overnights are possible and must be earned by good behavior; do not expect overnight permission for anyone with less than a 30 day good behavior record. **1 overnight per week.**
- Overnight passes must be approved 24 hours in advance. You must sign in and out when you leave and let staff know immediately upon return. EXPECT TO BE DRUG TESTED AT YOUR EXPENSE WHEN YOU RETURN, THIS IS A SAFETY ISSUE. An overnight pass is a privilege; you must be current with rent.
- 1 weekly house meeting is mandatory once per week, time to be determined.

- **Phase 2 meetings:** At least one 12 step recovery meeting is required for reach resident per week. Meeting cards need to be signed for every meeting attended.
- Absolutely **no smoking** allowed inside any building, you may smoke in the front yard or on the patio, all butts must be placed in ashtrays or butt receptacles and must be emptied regularly. This includes vaping and chewing tobacco.
- **Medications:** If your doctor prescribes medication for you, you are responsible for getting the prescription filled and taking the medication as prescribed. **No opioids, stimulants or steroids will be permitted and all prescriptions must be approved by administration before you fill them.** (this is for the safety of everyone involved in the house) We suggest ibuprofen or naproxen for pain relief and swelling. Administration is a phone call away
- **Fraternization:** Absolutely no dating, having intimate relationships or having sex on or off the property will be allowed. If at any time staff believes this is happening, both clients may be discharged. This also applies to same sex preference.
- **Evictions:** IF AT ANY TIME GOSHEN SOBER LIVING STAFF BELIEVES THAT YOU ARE NOT COMPLIANT WITH THE ABOVE RULES OR BELIEVES YOU ARE NOT WORKING AN HONEST, RESPONSIBLE RECOVERY PROGRAM, YOU MAY BE ASKED TO LEAVE. Decisions are made on an individual basis with consideration for the safety of the entire house community, as well as the needs of each individual. Any special circumstance discharge will be under the supervision of the House Director.
- **Rental agreement:** I understand that this is a week to week rental cycle, my rent is due Friday of each week. If for some reason it is not paid by the following Monday, I will be asked to leave and my deposit will be applied to that week's rent.

BY SIGNING BELOW, I AGREE TO ABIDE ACCORDING TO HOUSE RULES LISTED ABOVE. I HAVE READ THE RULES AND UNDERSTAND THEM COMPLETELY.
