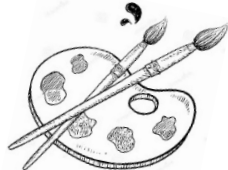
Submissions will be accepted from March 8 (District Board Meeting) to March 15, 2019 (District Council Meeting)

- 4. May use film or digital, color or black and white**
- 5. Entry label requires parent/guardian signature for submission into the contest.**
