# JULY COUNCIL MEETING

#### Members Questions

Question 2 - I requested that the excellent retrofit roadshow held in Kemble on 22 May, be extended to other corners of the Cotswolds such as Chipping Campden, Tetbury and Stow-on-the-Wold and also in the CDC Council Offices in Cirencester and Moreton-in-Marsh. I was delighted with the written answer and to see that plans are already in place for this to happen and indeed Cllr Gina Bloomfield had already organised such an event for Chipping Campden. In my follow up question I requested that officers prepare a pdf 'tookit' to accompany the roadshows which the Cabinet member thought was a good idea and would organise.

#### Item 12 - Report Back from British Farming Motion Task and Finish Group

Do you recall that at the 19 March full Council meeting, I put forward a motion, (seconded by Cllr Jeremy Theyer, who is a farmer), requesting the leader of CDC to write to the Chancellor Exchequer on behalf of Cotswold farmers, to pull back on her IHT on Farmers policy? At that meeting the leader T-boned a vote on my motion by proposing an amendment for it to be put to the Overview & Scrutiny Committee which was approved by the LibDem majority. O&S created a Task & Finish Group to consult with farmers and other stakeholders affected by the policy and produced a report. I thank those members and officers who put in a great amount of work and effort into the report which was presented at Council on 16 July:

#### ...that Council resolves to:

REQUEST that the Leader writes to the Chancellor of the Exchequer expressing concerns that the proposed changes to Inheritance Tax rules as they relate to farms will have unintended consequences that could have far reaching implications for the viability of the farming sector of the Cotswolds.

I am delighted that this item was approved by nearly all members, almost in its original form four months later, however the report has given the leader some background on what to say. I very much look forward to seeing the letter! As of 7 August, I have

received no notification that the letter has been written or sent and have emailed the leader to ask why it has not yet been sent.

# Have your say on the future of Gloucestershire councils

Residents are invited to share their views from 1 July until 9 August 2025. Three options are being developed for the new council structure:

One council covering the whole county.

- Two councils with an east (Cheltenham, Tewkesbury, and Cotswold) and west (Gloucester, Forest of Dean, and Stroud) split.
- Two councils, with one being an enlarged Gloucester city (referred to as 'GreaterGloucester') and the other covering the remainder of the county.

We are informed that public opinions on these specific options are not being sought. Instead, all seven councils are working together focused on gathering feedback on how local services can best meet the needs of residents both now and in the future. This means that the current political landscape is controlling a massive decision which will affect Gloucestershire for evermore. This decision is crucial, regardless of the eventual council structure.

I was disappointed by the quality of The "County-wide Local Government Reorganisation" Survey. It fails to ask key questions about Local Government Reorganisation or set out what are ALL the options.

Which model would you prefer - One Gloucestershire? Two Gloucestershire? East Of Gloucester? West of Gloucester? In my experience, when asked, most people say they want one Gloucestershire.

I also felt that many of the questions were inappropriate and insensitive - for example how is my sexuality relevant to this issue? Why would I be asked this? Is this survey simply a cynical data collection opportunity?

## COTSWOLD LOCAL PLAN TO BE UPDATED

Cotswold District Council is set to fast-track updates to its local plan to make sure homes are built in the right places at the right time, after government planning reforms more than doubled the number of houses the district is expected to deliver.

Work to update the plan at pace follows a government directive requiring the council to identify land for 1,036 new homes each year and increase of over 100% from 420 per year. - despite 80% of the district being within the Cotswold National Landscape, and the other 20% areas already much developed.

New housing targets mean developers are now more likely to pursue sites in the Cotswold district that were previously protected under the council's earlier local plan. Based on a lower housing requirement – set locally – that plan identified suitable locations for housing for at least the next seven years, exceeding the former five-year housing land supply requirement and placing the district in a strong planning position.

This update to the local plan aims to restore that position, ensuring future development is focused on the most appropriate and sustainable sites.

This work will be shaped with input from residents, businesses, communities, town and parish councils, environmental groups and others, with a public consultation inviting feedback in the autumn. As well as new homes, the public will be asked about schools, healthcare, jobs, transport, and other vital infrastructure to ensure communities have everything they need to thrive.

Once finalised and signed off by the Planning Inspectorate, the plan will guide development in the Cotswold district until 2043 and beyond. It is proposed that the update of the local plan will be completed by 2027.

Do you remember in my last Newsletter I reported that I had written to Cllr Mike McKewon, Cabinet Member for climate response, and I asked at him at the July Full Council Meeting to organise Retrofit Roadshows around the Cotswolds? I am delighted to say that he approved the idea and some events have already been rolled out - see below. I also asked that one should be held in the CDC Council Chamber in Cirencester and made available on a webcast which was also approved. I will share the link when it is available but at the time in writing I do not have a date for this particular event.

#### COMMUNITY GOVERNANCE REVIEW

The District Council has received two formal requests, one from a Parish Council asking to change to a Parish Meeting, and the other requesting an increase in the number of parish councillors. CDC are therefore preparing to undertake a Community Governance Review (CGR) and are inviting all other Parish and Town Councils/Meetings to consider whether there are changes you would like to propose.

#### A CGR can consider:

- Creating, merging, altering, or abolishing parishes;
- Changing the name of a parish;
- Reviewing electoral arrangements (e.g. number of councillors, warding);
- Grouping or de-grouping parishes under a common council;
- Changing the status of a parish (e.g. from council to meeting) to reflect local circumstances.

#### Proposed Timeline:

The review is expected to take place over the next 9–12 months, with any changes implemented at the ordinary elections in May 2027.

Requests should be made to <u>elections@cotswold.gov.uk</u> no later than 30 September 2025. An initial report will be presented to the Full Council in November and will include a timetable for the consultation process.

# The Cirencester Fire Station roundabout works have been completed!

It is very likely that over the past year you have been caught in traffic congestion due to these works!

The roundabout on the dual carriageway in Cirencester, closest to the Fire Station, along with the mini-roundabout at the junction of Love Lane and Midland Road, underwent a major upgrade to improve traffic capacity and flows, improve safety, and mitigate flooding in the area.

A drainage basin has been created in the central island, to mitigate flooding issues. This island was reduced in size to create extra lanes on the roundabout. The existing verges have been reduced to create a three-lane entry from Midland Road onto the main roundabout, and intelligent reactive traffic lights have been introduced to ease traffic flow.

Improvements have also been made for pedestrians and cyclists through the introduction of new at grade crossings on the eastern and southern arms of the main roundabout, and the existing footpaths have been resurfaced. The refurbishment of the existing subway will begin shortly.

Traffic lights on the main roundabout are operational 24hrs a day, these lights can detect vehicle levels and react accordingly to improve traffic flow. The two signal-controlled pedestrian crossings have been installed providing safe crossing points for pedestrians and cyclists which are activated by push buttons.

A control system is also in place, operated from the Fire Station, to ensure safe and quick access to the highway by the fire engines.
