



**TEMPORARY CLOSURE AND 30MPH SPEED RESTRICTION OF VARIOUS  
ROADS AND FOOTWAYS- A417 MISSING LINK (COWLEY, COBERLEY  
AND BRIMSFIELD PARISHES) COTSWOLD DISTRICT**

Gloucestershire County Council, as traffic authority, has made an order under the Road Traffic Regulation Act 1984 (as amended) to temporarily close those lengths of road as detailed in the Schedule below.

The reason for the said closures is for the construction of a National Highways Major Projects A417 Missing Link Scheme

The said roads are expected to be closed on a “rolling programme” commencing **21<sup>st</sup> September 2023**, where the presence of approved signage will indicate whether the closures and restrictions are in force. Further advance warnings of dates/times will be displayed on site prior to the closures taking effect. This order can permit the

closure of the roads in any order, or simultaneously as required and it is anticipated all works will be completed by **20<sup>th</sup> March 2025**.

### **SPEED RESTRICTION**

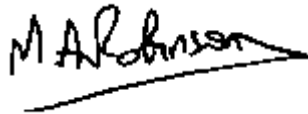
Gloucestershire County Council has also made the above Order, under Sections 14, 15 and 16 of the Road Traffic Regulation Act 1984 as amended, to temporarily restrict the lengths of road, as described in the above said Schedule, to a speed of 30mph.

The speed restriction is necessary to provide a safe environment for road workers moving heavy plant vehicles.
