


PAYING ESTIMATED TAXES ONLINE

FEDERAL ESTIMATES

With the IRS phasing out paper checks, the most secure and efficient methods for paying estimated taxes (Form 1040-ES) online include IRS Direct Pay (free from bank accounts) or your Online IRS Account.

When prompted for Reason for Payment, you should choose Estimated Tax and apply payment to 1040ES.

1. After choosing Make a payment → choose Direct Pay with bank account → Pay individual tax → Make a payment
2. Complete the Tax Information screen
3. Reason for payment → select Estimated tax
4. Apply Payment to 1040ES
5. Tax Period for Payment – 2026
6. Verify Identity

STATE ESTIMATES

▪ **MD**

For paying Maryland estimated taxes online, the recommended method is using the Comptroller of Maryland's website to make secure, direct debit payments. The Maryland iFile system allows you to schedule all four quarterly payments at once. The website is interactive.marylandtaxes.gov/individuals/IndivLogin/default.asp

OR on the MD website (marylandcomptroller.gov) → choose to Make a Payment → select Estimated Payments → under the Other Online Options, choose *Make a personal estimate* → finally, it will bring you to the logon screen for the individual taxpayer online service center, where you can register or logon if already registered.

To pay Pennsylvania estimated taxes, use the myPATH portal to pay online via ACH bank debit or credit/debit card without logging in. The myPATH system lets you select "estimated tax payment" and enter your details for quick electronic payments.

The website is pa.gov/services/revenue/make-a-personal-income-tax-payment

OR on the PA website (pa.gov/agencies/revenue) → choose Pay → Make a Personal Income Tax Payment → select Make a PIT payment with myPATH → under Payments choose Make a Payment → select Make a Payment again. It should bring you to this screen:
