Queensland guidelines for nomination in the NIV *Innovative Investors* pathway include proposals that invest a minimum of \$5 million for two or more years through asset managers that deploy private equity,

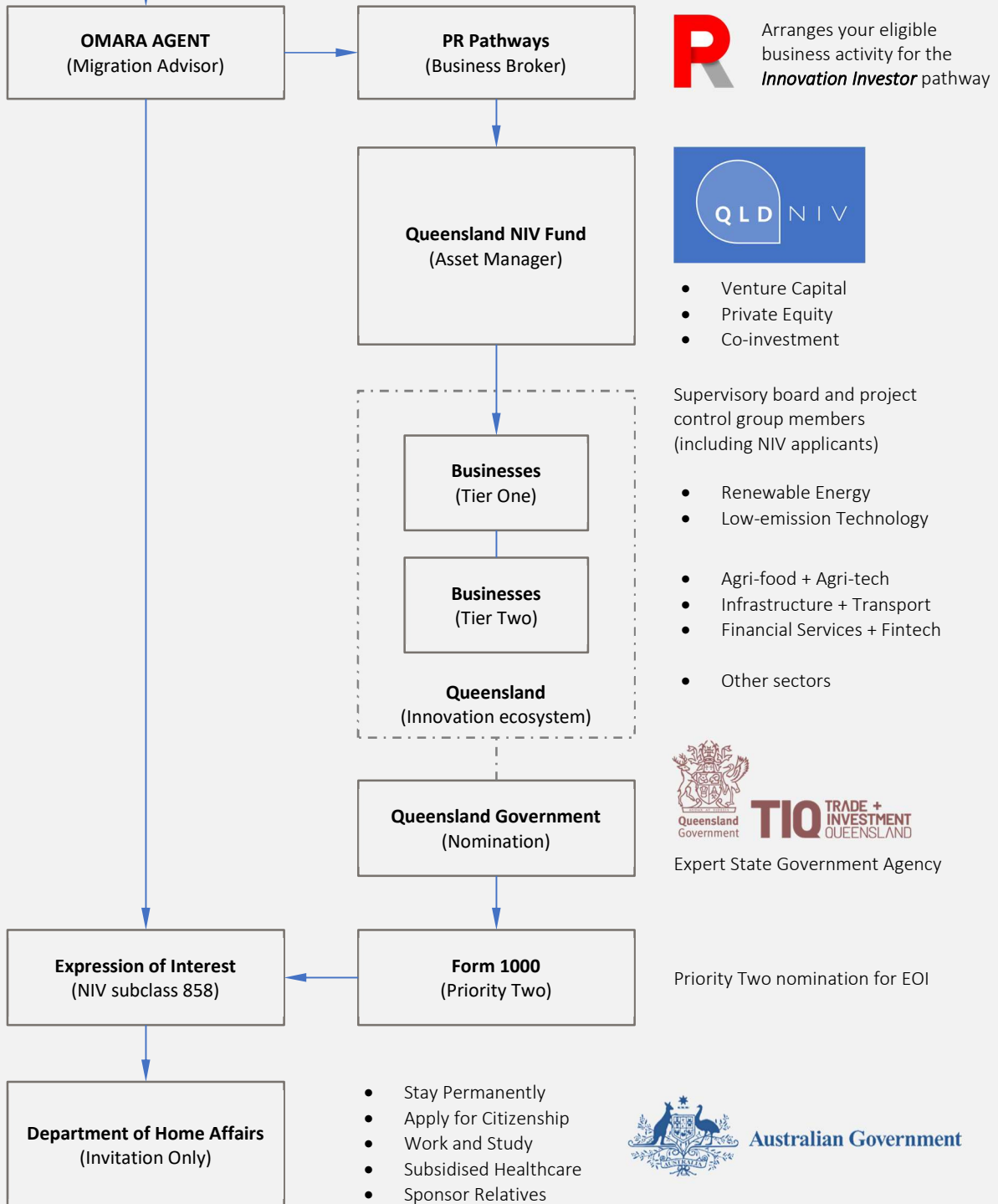
venture capital and co-investment that align with the Queensland government innovation ecosystem and strategic initiatives.

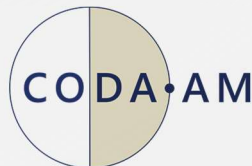
