

Boarding Policies and Release Form

While your pet is staying with us, we assure you that he/she is receiving excellent care and our full attention. Your pet is staying in our climate-controlled facility. Dogs are taken outside (weather permitting) a minimum of 3 times daily.

Vaccinations: All boarders must have current Rabies vaccinations in order to board. This is a law by state law, and I have no control over it. We require Bordetella (kennel Cough), Parvo/Distemper. Must have copy presented at time of boarding. Must be up to date.

Fleas: It is best to have your pet on a pest preventative, by doing so, you are taking your part in pest control. We do our part by spraying the facility weekly. All pets in my business with flea and or ticks will be bathed at the expense of the owner. X _____

Diarrhea: Boarding can be a stressful experience even for a dog who has been in kennels multiple times in the past. After all, no animal likes to be separated from their owner regardless of how temporary the break might be. The sights, sounds, smells, and new people associated with the facility and his doggy vacation may also be unnerving at best, and it is not unusual for dogs to become a little withdrawn and anxious until they settle in. Unfortunately, much like us, a dog's stress can manifest as an upset stomach and he might have diarrhea both during and immediately after his experience. Some dogs also develop mucus and even a little blood in their stools due to stress. If your pet shows signs of diarrhea during their stay, you give Candy Pet Palace, its staff, or associates permission to give an oral probiotic at owner's expense. \$3.00 per day until diarrhea resolves itself or until such pet is picked up from boarding; whichever comes first. If Candy Pet Palace, its staff, or associates do not see signs of diarrhea during your pets stay and diarrhea is present after the pets stay with Candy Pet Palace, owner will not hold Candy Pet Palace, its staff or associates liable for any medical/medication/Veterinary cost. x _____

Grooming: The kennel cannot be held responsible for matted pets. Prior arrangements must be made with the groomer, if an actual grooming is requested X _____

Estrus in Female: If a female is in estrus, and we are not notified and breeding takes place, Candy Pet Palace & More or its representatives are not liable. X _____
