Grant County Fire District 8 (District) is accepting applications to update the hiring list for future positions.

District Profile:

The District is in South Central Washington and is a rural combination fire district with a response area of 248 square miles. We responded to 599 calls in 2025 from three stations with 61% medical calls, 15% good intent (canceled calls, no incident found, authorized burning). 10% motor vehicle accidents, 8% structure, vehicle, trash, and wildland fires, 6% false alarms and service calls. We provide structure and wildland fire suppression, BLS transport, hazardous materials response and technical rescue, and fire prevention and safety education to our citizens.

Our headquarters station has career and resident housing. Current strategic initiatives include continuing to upgrade capital facilities, increasing staffing as budget allows, developing personnel, and capital replacement of the fleet. We take pride in continually improving the services that we deliver to our community.
