Grant County Fire District 8 (District) is accepting applications to create a list for future positions.

### District Profile:

The District is located in South Central Washington and is a rural combination fire department with a response area of 248 square miles. We responded to 702 calls in 2022 from three stations with 82% EMS related, 10% wildland fires, and the balance being structure and other types of fire calls. Call volume has increased more than 25% in the past five years. We provide structure and wildland fire suppression, BLS transport, hazardous materials response and rescue, and fire prevention and safety education to our citizens.

Our headquarters station has career and resident housing along with space for a ladder truck that will arrive late in the first quarter of 2023. Current strategic initiatives include continuing to upgrade capital facilities, increase staffing as budget allows, developing personnel, and capital replacement of the fleet. We take pride in continually improving the services that we deliver to our community.
