Grant County Fire District 8 (District) is accepting applications to establish an ongoing eligibility list for the position of Resident Firefighter.

District Profile:

Grant County Fire District 8 is located in South Central Washington and is a rural combination fire department with a response area of 248 square miles. We responded to 509 calls in 2020 from three stations with approximately 80% EMS related, 13% wildland fires, and the balance being structure and other types of fire calls. Call volume has increased 35% in the past four years. We provide structure and wildland fire suppression, BLS transport, hazardous materials response and rescue, and fire prevention education to our citizens.

We completed construction of a new Headquarters Fire Station July 2021. This station has career staff and resident housing and space for a future ladder truck. Current strategic initiatives include continuing to upgrade capital facilities, increase staffing as budget allows, developing personnel, and capital replacement of the fleet. We take pride in continually improving the services that we deliver to our community.
