About the District

Grant County Fire District 8 serves 248 square miles in south-central Washington. In 2025, our crews responded to **599 emergency calls** from three fire stations, with the majority involving emergency medical services.

Our team provides:

- Emergency medical services (BLS ambulance transport)
- Structure and wildland firefighting
- Rescue services
- Hazardous materials response
- Fire prevention and community education

Our Headquarters Station is home to both career and resident firefighters and houses a 100-foot platform ladder truck, structure engine, two wildland engines, water tender, brush truck, and two ambulances.
