On 30th September Dave Love and myself met with Donna Faragher to show her first hand the Ashfield Flats foreshore area and the wetlands which are a Bush Forever site.

We welcomed her interest and obvious knowledge on the various issues.

She agreed that this concern needed to be taken further and has pushed for a meeting with John Day, The Minister for Planning's office and staff from the Western Australian Planning Commission.

As the WAPC is the landowner, it appears to be a pretty critical

step into finding a solution to getting better management of the area and a plan to deal with some of the issues that have been identified on the Ashfield Flats.

We are hopeful for a meeting in mid November to share our views with representatives from these Departments.

I am still convinced that the area needs a substantial management plan as the management of the area seems to be very disjointed at best and a lot of issues are not being addressed or just ignored.

Erosion is getting worse, amenity is being lost and the wetland area is degrading.

As the wetland area is a 'Bush forever' site that has been identified as being significant as a wetland, then surely it demands to be looked after and preserved. We cannot afford to let this area degrade completely.

Hopefully these will be steps in the right direction for getting a better outcome for the area.

In addition, a submission was put into council regarding the street tree master plan and how this could change in Ashfield now that we have no overhead powerlines.

One of the main features of the AshfieldCAN each year is the newsletter and I would like to thank Dave Love for his continued contributions in making this happen. They are a great resource for the AshfieldCAN and I know we all enjoy reading them.

AshfieldCAN President's Annual Report

Another year has flown by and I can't believe we have come to the end of another AshfieldCAN year.

The AshfieldCAN has continued to do great works in Ashfield.

This year started the Garage Sale trail at Gary Blanch Reserve. This was very successful and thanks to Marion Cahill for organising this event and for taking on the task of organising it again this year.

The usual Christmas function followed on next which was most enjoyable and then there was a bit of a break at Christmas and over the summer.

We started the new Year with the Bus stop project, painting bus stops with the Cyril Jackson Students. This was another successful and well received project.

The major Project this year has been the Gary Blanch Reserve and what a transformation it has been. This project has been amazingly successful on many levels.

We have seen the park change from a dry, drab space into a vibrant community asset that is getting used constantly by the local community. That in itself is so gratifying.

The park has been remodelled with the two nature play areas, planted gardens, paths and lawns making a tremendous difference to the space. All this has been masterminded and overseen by Emma Slavin. She has done a sensational job getting the community vision to become a reality.

With the Planting day for the community, the planting day with Ashfield Primary School, the making of the rock gardens with other AshfieldCAN members it has been a true community effort. The park is something that is of significant value to this community now.

River Gathering

We really do live in a fortunate country, where people from all political persuasions, State agencies, community groups and other walks of life can come together and express diverse opinions in a friendly, non-adversarial environment.

Such was the case recently when Ashfield Community Action Network (AshfieldCAN) hosted an evening river ramble along the foreshore at Ashfield Flats to discuss the often vexed question of how to preserve and restore our ailing Swan River.

The well attended gathering was hailed as a bipartisan starting point from which to achieve worthwhile change that, it is hoped, will set a benchmark to be duplicated and eventually transform our myriad of wetlands in the upper reaches of the Swan River system to a point where they again contribute to the health of our estuary.

Our meeting place, Ashfield Flats, is an example of sometimes well-intentioned human intervention causing harm to our environment. In this case a dying environment, paradoxically enshrined as iconic 'Bushland Forever' and acknowledged as an ancient breeding area for life so important to the health of the entire estuary.

The gathering identified harm has been caused by a range of human interventions and actions, from the earthen pedestrian pathway obstructing the ebb and flow of natural water movement, to the destruction wrought by the wash of ever increasing river traffic, gouging at fragile river banks. Even decades-old river realignment was identified as causing constant wind-wave destruction. The mass mortality of large wetland trees and stagnant, mosquito breeding toxic ponds, devoid of once abundant frog and other aquatic life is a stark indictment of our inability to tackle the degradation of this immensely valuable community asset. What we now understand is that this degradation is essentially a bureaucratic problem, for as the meeting identified the wetlands have done the rounds of Government agencies and incongruously this iconic area is now entrusted to the WA Planning Commission. It was generally agreed this environmental catastrophe should not be a 'planning' issue as it is outside their scope of responsibility and therefore unlikely to receive priority attention and funding for the restorative work so desperately needed.

Discussion centred on the amalgamation of the

municipalities of Bassendean and Bayswater as representing a great opportunity for the new entity and the government of our State to come together as a team to repair and nurture the upper reaches of our great river.

The gathering ended on an optimistic note as it was acknowledged that which is done can, to some extent, be undone. Science and engineering can be focussed on identifying and fixing the problems. If boats cannot be stopped (and they can't) then environmental engineers can be employed to mute their effect. Public education and policing of boat speeds can be undertaken. A combination of public amenity and environmental areas can be established. Earthen footpaths can be replaced with raised boardwalks. Steep clay cliff faces can be supported and protected from erosion. More wetland trees and rushes can be planted and riverbank profiles can be returned. The rest, as they say, can be left to nature.

Notwithstanding the many issues surrounding council amalgamations, the vast number of people who care, should demand of those who represent us, that our river's health be given the priority it deserves.




Ashfield Residents' Interests Photography

Reflections of colour and light

A unique photographic series of the Swan River has been recorded by Ashfield resident John Goldsmith. Over many months, John built up a photographic record of the Swan River and its amazing visual variety, under a wide range of lighting conditions. He photographed the light, colour and patterns created by the river's surface, and all of the images were all recorded along a small stretch of the river, near the Ashfield fishing platform. The result is a superb mosaic image showing the range of light, colour, waves, reflections

He has led photographic workshops aimed at helping people achieve better photography of the Swan River dolphins, as part of the Dolphin Watch / River Guardian volunteer program (with more than 600 volunteers in Perth).
