## RT Dems would like to congratulate High School and College graduates on their well-deserved success.

Planning Board: After a lengthy presentation by developer Woodmont Properties, and comments from the public, the Board approved the preliminary site plan for the Woodmont US Bronze warehouse project located on Rte. 202 and Voorhees Corner Rd. 1000 feet from J.P. Case Middle School and 600 feet from Concord Ridge. Woodmont Industrial Partners proposed a 353,830 square foot warehouse (the size of at least 6 football fields) that will sit on a 28.76 acre plot, consisting of 36 loading doors, 23 knock-out loading doors for a future tenant, 197 parking spaces with handicapped parking and EV spaces. Engineer Karl Pehnke testified before the board on behalf of the study and said that he anticipates about 49 vehicles arriving during the morning peak hours between 7:45-8:45 and about 62 vehicles leaving the sit in the evening peak hours. He states that "the level of traffic that we are adding to those intersections would not be considered to be significant by the department of transportation to the point that they would be concerned", and that "we find the traffic added by this project will not materially change the current experiences at those intersections." <u>Flemington Raritan School District:</u> At the May 2 School Board meeting, 41 members of the public, including **Mitchelle Drulis, Khush Pall, and Kent Davis** spoke out against the staff cuts to school personnel. Despite public opposition, FRSD voted

8-1 (Member Jeff Cain voted against the \$80M budget) to eliminate 33 positions including librarians, special education teachers, and teaching assistants.

## A message from LD 16 Assemblywoman Mitchelle Drulis:

It's almost Summer which means school is almost out for our K-12, and our College students are back. Speaking of school, I am happy to share that the Governor signed A4161 (Frieman/Drulis/Katz/Zwicker/Gopal) that established Stabilized School Budget Aid Grants to restore state school aid reductions. Hunterdon Central was one of the effected schools, and I am happy we were able to get a portion of the aid restored.

The legislature is going full throttle in June. Budget hearings are over, and your LD 16 legislative team has already submitted our budget priorities. Over the next few weeks final details of the state budget will be worked on and we will vote on the final budget before the deadline of midnight on June 30th. Once the budget is passed, I will share more information.

This month, in addition to my three regular committees, I was asked to sub in on the Assembly Tourism, Gaming and Arts Committee, where we voted a bill out of committee that requires the division of travel and tourism to maintain a website of historic sites, districts and roadside markers. We have so many historic places right here in Raritan, such as Gearys Ridge for example, that I joined on as a co-sponsor to the bill. We are counting down to the 250th Anniversary of the United States and I encourage everyone to visit REVNJ.org to check out upcoming events and great places to visit this summer.

Continuing with the goodness of summer, who doesn't love Jersey Fresh produce!?!?! If you are thinking about Jersey blueberries, early harvest isn't until June 10th so instead try some strawberries which are being harvested this week. Check out the NJ Dept of Agriculture's Jersey Fresh website

Please consider reaching out to Governor Murphy to urge him to VETO the new proposed OPRA Bill, as it grossly discourages residents from submitting OPRA requests. The new Bill includes provisions that shift the legal fees to the requestor if the request is denied, reducing the incentive for the agency to comply. The Bill would also allow governments to sue requestors they believe are "seeking to substantially interrupt the performance of government function" and it would also allow a judge to limit the number or scope of requests the requestor could file if the government prevails. At a time when we need more transparency, not less from our BOEs, local and county-wide representatives, this bill could be devastating to residents limiting their ability to fact-check. Text Gov.
