We'll keep an inventory list of everything you leave with us, and send it to you for final approval before we display your things. What We Accept-

We love items that are new, like-new, or excellent condition.

Consignment Period & Earnings

Your items will hang out with us for **60 days**:

Days 1–30: You earn 40% of the full retail price

Days 31–60: Items are discounted 20%, and you still earn 40% of that price

When your 60 days are up, you can pick up your unsold items. If they stay past that, they become part of the Wicked Wardrobe family.

Tip: We don't send reminders — it's up to you to collect your pieces! Call or email us 60 days from today to set up a pick-up date.

• Items not picked up within 7 days following the end of the 60-day consignment period will be forfeited to the Wicked Wardrobe.
