

# CLUB RULES

1. Members and guests are responsible for their own safety, first aid, and equipment on club property. Farmington Sportsmen's Club Inc., will not be responsible or liable for members, members family, guests, boats, trailers, tents, or any other equipment on club grounds.
2. No intoxicated person is allowed on club property.
3. No swimming on club property. Permissions for special use of raft type floatation must be issued and signed by the president and vice president.
4. Electric trolling motors only. Gas motor use for club purposes only. Boats on club property must meet state requirements and have a visible name of the owner.
5. **Pole and line fishing ONLY.** Limit 2 poles per person. IDNR laws and limits apply. This means absolutely NO jug fishing, trout lines, throw nets, net fishing supplies, etc. are allowed on club property. No exceptions.
6. No hunting. Permits for use of firearms must be issued and signed by the president and vice president. No air rifles or bow and arrows.
7. All waste solid must be disposed of in places and containers provided by the club. Do not dump fish entrails in the dumpster. No dumping of outside materials.
8. Pets must be on a leash. No pets allowed in the clubhouse anytime or in the clubhouse vicinity during events. If your dog leaves a mess around the clubhouse or another member's site, be a responsible owner and pick it up.
9. Off-road type vehicles (ATVs/UTVs) or mini-bikes are NOT allowed on club property. Small child battery operated type toys are allowed daytime only.
10. Fishing requests for guests are restricted to two per year.

**11. Speed limit 10 mph and strictly enforced.**

12. **Members are not to give out the gate combination for any reason.** Gates are to be locked at all times unless there is a club function. This includes any outside maintenance services to campsites. If discovered, membership will be lost.
13. Children on grounds or in clubhouse must be accompanied and supervised by an adult.
14. Clubhouse is off limits while being rented. Clubhouse rental fee is \$500 per day with a refundable \$250 deposit and \$100 for any additional days requested. Contact the Vice President for available dates excluding Memorial Day/4<sup>th</sup> of July/ Labor Day.
15. No blocking gates or boat ramps.
16. Members must be present when guests or family members 21 and over are on club property.
17. Members are allowed to leave one boat/trailer in designated boat parking areas with a name clearly visible. Boats must be in working order. Abandoned boats will be removed. No enclosed trailers, utility or car trailers are allowed. Kayaks should be stored on a rack or off the ground in some fashion.
18. All children 9 years and younger must wear a life-jacket at all times on boats and docks and around the lakes. All state guidelines apply.
19. All docks are considered club property and accessible to members. Boat slips are meant for pontoons only. Electric use from dock stations only. Use of extension cords from any other source is not allowed.
20. Members are responsible for any type of club related social media post. The club Facebook site is meant to be informative.

# CAMPING RULES

1. Overnight campers should register a week ahead of time. Camping fee in designated areas cost \$20 per night for non-electric and \$30 for electric if available. Contact the camp master for more information.
2. Campers are responsible for maintenance of their area. Sites are expected to be maintained and kept clean and orderly and without clutter.

Tires cannot be stored or used for landscaping.

No storage of any vehicles, utility, car, dump trailers etc.

Only one boat/trailer is meant for temporary use only.

Grass is not to exceed 12 inches. If the club has to mow, a charge of \$50.00 for first offense and \$100 for second offense; the third offense could result in the termination of campsite privilege.

Electric sites should not have utilities on when offsite unless you plan to return the same day when weather is extreme. If notified, you are expected to shut off usage the same day. A charge of \$50 for the second offense and \$100 for the third offense. Further offenses could result in termination of campsite privilege.
3. RV's/Trailers must remain habitable and in good repair. No tarping or other measures meant to be temporary are allowed. Trailer skirting is not allowed.
4. Campsites are intended for recreational use only. Extended or full-time residency is prohibited. Members may occupy their campsite for a maximum of 14 consecutive days and no more than 60 days total per season. Members may not use campsites for personal storage, commercial activities, or other non-recreational purposes. Enforcement relies on self-compliance, with board oversight for complaints or obvious violations.
4. Quiet time on club property is 11pm to 8am. No music or large fires after 11pm. Generators should be sheltered to reduce noise.
5. Human waste must be dumped in the dump station.
6. One trailer allowed per membership. Temporary/overnight camping for guests on a members site is allowed. Overnight fees still apply – see rule #1.
7. Permanent campsites may not be transferred with the sale of a trailer. Members will be responsible for sale or removal of any deck or shed structure. Campsites cannot be traded for another site without camp master approval.
8. Consult the board before removing any mature trees.
9. Subleasing campsites to other members is not allowed. Campsites are leased to one member at a time.
10. All sheds/lean-to's must have pre-approval before construction begins or will be subject to removal. Shed size cannot exceed 10x12 and lean-to's cannot exceed 4x8. Sheds must be kept in usable condition. No holes, working doors, etc to keep critters from inhabiting. Proper building materials apply, no temporary materials like tarping are to be used on sheds or lean-to's.
11. All decks must have pre-approval before construction begins or will be subject to removal. Size cannot exceed size of trailer and remain moveable, no footings. No more than 3 walls with suitable building materials only. No use of tarping or temporary type materials is allowed.
12. Permanent campers may move their trailers out for trips. There is no obligation to have a trailer at your site. Site maintenance still applies, see rule #2.
13. Camping dues are due by February 1st. If full payment is not received by March 1st, the campsite will be forfeited.
14. Do not block roads or park in your neighbors parking area.
15. Camping members with permanent campsites are allowed to have electric or gasoline powered golf carts.

Only permanent campers may have a cart and it must be stored on their site. Non-electric members may charge carts at the fish house. Must be operated by a person 16 years of age or older. A \$20.00 fee will apply. Carts must have working headlights and tail lights for safety reasons. It is each member's responsibility to provide liability insurance for golf carts and trailers. The club is not responsible for members or guest personal property.
