

CLUB RULES

1. Members and guests are responsible for their own safety, first aid, and equipment on club property. Farmington Sportsmen's Club Inc., will not be responsible or liable for members, members family, guests, boats, trailers, tents, or any other equipment on club grounds.
2. No intoxicated person is allowed on club property.
3. No swimming on club property.
4. Electric trolling motors only! Motors are allowed for loading and unloading only as needed. Boats on property must meet state requirement and have a visible name of owner.
5. Pole and line fishing only. Limit 2 poles per person. IDNR laws and limits apply to ALL persons fishing. NO jug fishing or trout lines.
6. No hunting. Permits for use of firearms must be issued and signed by the president and vice president. No air rifles or bow and arrows.
7. All waste solid or human must be disposed of in places and containers provided by the club. Do not dump fish entrails in the dumpster. No dumping of outside materials.
8. Pets must be on a leash.
9. Off-road type vehicles (ATVs/UTVs) or mini-bikes are NOT allowed on club property. Small child battery operated type toys are allowed daytime only.
10. Fishing requests for guest are restricted to two per year.
11. **Speed limit 10 mph and strictly enforced.** Please obey the limit for the safety of our children.
12. **Members are not to give out the gate combination for any reason.** Gates are to be locked at all times unless there is a club function. This includes any outside maintenance services to campsites.
13. Children on campground or in clubhouse must be accompanied and supervised by an adult.
14. Clubhouse is off limits while being rented. Clubhouse rental is fee is \$500 per day with a refundable \$250 deposit and \$100 for any additional days requested. Contact the Vice President for available dates excluding Memorial Day/4th of July/ Labor Day.
15. No blocking gates or boat ramps.
16. Members must be present at all times when guests are on club property.
17. Members are allowed to leave one boat on club property with a name clearly visible. Abandoned boats will be removed. Please keep grass mowed from around boat.
18. All children 9 years and younger must wear a life-jacket at all times on boats and docks and around the lakes.

CAMPING RULES

1. Overnight campers must register. Camping fee in designated areas cost \$20 per night for non-electric and \$30 for electric. Contact the camp master for more information.
2. Campers are responsible for maintenance of their area. Grass is not to exceed 12 inches. If the club has to mow, a charge of \$50.00 first offense and \$100 for second offense; third offense will be termination of camping privilege.
3. RV's/Trailers must remain habitable and in good repair. No tarping or other measures meant to be temporary are allowed.
4. Quiet time on club property is 11pm to 8am. No music or large fires after 11pm.
5. Human waste must be dumped in the dump station.
6. One trailer per campsite. Temporary/overnight camping for guest is allowed. Overnight fees still apply – see rule #1.
7. Old tires may not be used for any reason, such as landscaping, etc.
8. Permanent campsites may not be transferred with the sale of a trailer.
9. Permanent campsites are leased to one member at a time.
10. Subleasing campsites to other members is not allowed.
11. All sheds, decks, etc. must be approved by the board of directors before construction begins. Shed size cannot exceed 10x12.
12. Permanent campers may move their trailers out for trips. If camping site is paid, there is no obligation to have a trailer at your site. Site maintenance still applies.
13. Camping dues are due by February 1st. If full payment is not received by March membership meeting, campsite will be forfeited.
14. Do not block roads or park in your neighbors parking area. Respect other camper's area.
15. Camping members with permanent campsites are allowed to have electric or gasoline powered golf carts.

Only permanent campers may have a cart and it must be stored on their property. Non-electric members may charge carts at rental site or fish house. Must be operated by person 16 years of age or older. A \$20.00 fee will apply. Carts must have working headlights and tail lights for safety reasons.

It is each member's responsibility to provide liability insurance for golf cart and trailers. The club is not responsible for members or guest personal property.
16. Please address questions/concerns at the monthly membership meetings. Be respectful of others recreational time while on the grounds.
