## PART 4

### **The Heart of the Economic Matter**

#### **The Cost-of-Living vs the Eternal Have/Have-Not Struggle**

But, the Republicans in the P47 controlled US Congress has killed the Affordable Care Act insurance subsidies for millions of Americans. That 500,000 will only go up! Last year the nation of France had ZERO medical bankruptcies.
- AI will be taking more jobs that provide health insurance. Even employers provided medical insurance will be too expensive for more people in 2026.
- The Medical Insurance Industry does not feel any responsibility to cover all Americans. Think about that, folks.

## Europe and Socialized Medicine

So, they prudently built social services to help everyone because no one had anything! Meanwhile, over in America, the for-profit medical insurance and pharmaceutical industries just kept making money, paying stockholders, and increasing rates and prices every year. And here we are today with corporate profits, executive compensation, stockholder dividends, and higher medical insurance premiums than ever. So, there it is.

That annual number of 500,000 medical bankruptcies is going to go way up since the Republicans didn't pass an extension of the ACA for even one year. You know, so the Republicans have more time to produce their mythical alternative medical insurance option. And P47 could finally fill us in on his medical insurance concepts. ## PART 5

### ***Our Third American Civil War*** ***Our Second and Final American Revolution***

It was countrymen fighting the bloodiest of warfare to determine whether America would remain a single nation. The North prevailed and the Union was maintained. Their heroic and bloody struggle ***Preserved our Democracy***.

4. Now some 160 years later in 2025, I declare that we are now living in our ***Third American Civil War***. I will note here and detail later, “America is not a racist nation”.

## PART 8

## **1. Removing Any Violent Students from pre-K, Kindergarten, first grade, and second grade in All Public-School Classrooms by January 30, 2026**

Yes, this is too real, folks!

Problem: Someone could have or had a child getting beaten up in pre-K; kindergarten, 1<sup>st</sup> and 2<sup>nd</sup> grades.

Briefly, there is a Federal Guideline from the Dept of Education in place that is enforced in all 50 states. The Guideline totally prohibits removal of a physically violent child from those classes, IF, he or she has an IEP program i.e., some type of learning challenge.

Federal and State lawmakers have refused to modify those Guidelines to allow such children to be removed. It literally only requires a few lines to correct. And some common sense. They will not touch it. But they will now.

### What to do About It

The TARF and the USNA, on behalf of the students, parents, Principals, and Vice Principals, Demands that all 50 Governors issue Emergency legislation in January 2026 to correct this situation until the Dept of Education updates the related appropriate Guidelines.

I am in the process of contacting MY3 US Congress members from Maryland. All of us have what I call MY3 in the US Congress. Check them out. They should be working for you.

Maryland Senators Chris Van Hollen and Angela Alsobrooks, and US 2<sup>nd</sup> District Rep Johnny Olszewski I will be introducing myself, TARF, and the Platform proposals to them. Starting with getting those Violence Guidelines updated soon. They are the legislative part of my team! We will work together to promote prudent and practical TARF legislation and helping to reform the Democratic Party into the Moderate political force the nation requires them to be now.

### The Challenge

I would request all of those with such violent occurrences in their emotional history, past or present to please start calling your State Governor's Office and report it every week! To **only** place those calls on Tuesday afternoon each week until the problem is fixed in your school(s).

Also to call and follow-up with the major newspaper in your State to report it weekly. Although some of these cases are reported, it has not been adequately pushed – considering the abuse that continues at some level to this today.

Just supply the name of the school, grade, dates, etc. No names. It might sound odd but depending on how many calls may come in at first it could be a burden for them to handle. The Governor's Office will then be expected to track and report out to the Public and Press.

No, the police can't touch it. There is no telling how many of these situations are or have happened because it is not reported to the Public. It could be a freak occurrence. But there were two elementary schools in my own County in Maryland in the 2023/2024 school year with this exact problem. There are over 3,000 county type jurisdictions in America.

Good News! This behavioral problem could very well cease to be a problem by the end of January (2026). Direct public action gets results. We win!!

## **2. Removing all communication devices from Public School Buildings by January 30, 2026**

Restricting all Cell Phone and Communication Devices from ALL Public-School buildings as of 1-30-2026 by Public Demand and United Parental Action.

### Global Impact

This Cell Phone proposal is intended to be Global in scope. News groups in the US and internationally, e.g., BBC World will be contacted to spread this positive message. Challenging High School Principals and parents worldwide.

The TARF and the USNA, on behalf of the students, parents, Principals, and Vice Principals, will respectfully Demand immediate action at the individual school level. All 50 Governors and the Press will be made aware of this action. However, there is little chance they and their State Legislatures will act as promptly as necessary. Which is January 2026. This issue has been and is being “studied to death” for years. And the only thing that is dying is Public Education.

We the People via this common-sense action, will give some 95,842 Principals, some 95,842 Vice Principals, and some 3,100,000 teachers the greatest Christmas gift they could ever receive. To once again have control over their schools and their own classrooms. Any questions??

Public schools are there for 2 basic reasons. First educational development. To teach subject matter to students in grades K-12. Second for personal social development. To interact with other people as they grow from 6 to 18 years old. Cell phones only damage the learning and socialization environments. Phones belong at home or in the parents car.

This is a global learning crisis. The governments of the world will not simply end this avoidable learning crisis. They bow to what I call the ***Cellphone and Internet Click Industries (CICI) Group***. It will simply be reviewed with the parents, signed, and returned the next day to the principal's office. If and when there is a 2<sup>nd</sup> occurrence the device will be held at school for one week and can be picked up only by the parent.

If there is a 3<sup>rd</sup> occurrence the parent will be given 3 options, which are:

- Get with the program and leave devices at home.
- The school will provide the parents with a few viable Home-Schooling options they pursue with their students.
- The school will provide the parents with a few viable Private school options, as well.

### 3. Demanding Quality Phonics Learning as It is Needed in Base Learning Immediately.

There are so many School Curriculum Administrators with a lot of explaining to do...

Cell phones and Phonics are educational hot buttons for me. I have some practical background related to public education and will gladly share some of that right now for common understanding. And answers for frustrated parents and kids.

See TARE Problem Solution #3 later herein.

First let me tell you why your son or daughter was doing so well through the 3<sup>rd</sup> grade and then hit a learning and/or reading wall. This problem is worldwide! In America it normally impacts at least 20% of the school population.

As a result, some schools are now offering parents a waiver to sign. It will allow their elementary school students to go, for example from 3<sup>rd</sup> to 4<sup>th</sup> grade without being able to read at grade level. Until about the 4<sup>th</sup> grade inmost schools students only need to know pieces of information. Words, numbers, etc. However, the curriculum then requires students to read or hear or view information and then to respond to questions about that data. And they hit a learning wall and grades go down. Now let's talk about why that happens!

In the first 2 years of life, most of us learn the 44 Phonemes that forms the base of our American language. Yes, I said American language! Have you ever heard an Englishman speak? We all lay there in the crib listening and unknowingly recording those critical sounds patterns. It is important to understand that our brain naturally allows us to talk. However, reading is not a natural ability. Thus, we must learn those critical sounds. And then learn how to match those sounds into letter patterns or words to learn to read. That is if all goes well.

However, comma! In the first 2 years of life, if any child has multiple serious ear infections, excessive ear wax, water in the ear, etc. many of those critical 44 Phonemes are understandably corrupted. They are still stored but are garbled rather than being pure in quality. That's the problem folks. I know this because I have that problem – excessive ear waxes my entire life. I did not know about my problem until my early forties. I have successfully dealt with it.

And unless those patterns are somehow re-learned that child will have trouble reading and studying for the rest of their life.

Phonics is name for programs that teach sounds and patterns and words. So that students (and adults) can learn to read. Having phonics issues does not mean a person cannot read, but it is slow process for them every time.

Simply put, Curriculum Administrators nationwide walked away from Phonics a few decades, and the school systems began to crash. Many are stumbling back to it now. The proper teaching of Phonics must be accelerated even this school year.

A Phonics program must be functional. That is, before it is pretty or entertaining. It must teach basic sounds and how to build words. Many of them do not.

I will make a non-paid reference here to the *Ultimate Phonics* program provided at SpencerLearning.com. For school and home use. I know of the product and its quality.

The creator of *Ultimate Phonics* has a helpful suggestion for parents. If you have any concerns about your child's reading ability, he suggeststhe following simple exercise. Parents select a book that your student should be able to read comfortably. Then sit together privately and have them read aloud to you.

That's it! You will both have the answer in a minute. If they stumble over words, then there is work to do. And a good Phonics program is the place to start.

Does your student's school have one? Go get them...

#### **4. Reducing the High Cost of Higher Education**

It is simple. Most of the population cannot afford college tuition. Time for a little, “*Shock and Awe*”.

Reduce tuition for ALL 4-four schools by 25% for the 2026/2027 and 2027/2028 school years. Due to bad academic results and frankly because tuition and board are rudely over-priced. A similar tuition reduction for Community Colleges, but possibly a lesser percentage reduction. To be determined. That is where the negotiations will begin but expect little movement.

## 5. The TARF Comprehensive US Immigration Reform Proposal

This is the American Agenda Proposal #5 – American Population Management from my book, *The Second Coming of Common Sense (CS2)*.

I will now present what I like to call Human Numbers. This is a reality check for Progressives! Read and consider for yourself, please.

### The US Census 2000 versus 2020 Population by Racial Breakouts

Now for a serious reality check on the US Citizen population. The following statistics are from the US Census for 2000 and 2020. I found it surprising the first time I saw these numbers. Those that are and are not concerned about “white replacement” issues, check this out. Over those 20 years the:

- White American population increased only, 1.3 million; under 1% increase.
- Black American population increased, 7.9 million, a 22% increase.
- Asian American population increased, 9.4 million; a 93% increase.
- **Hispanic American population increased, 23.8 million; a 64% increase.**
- Total American population increased, 43.0 million; a 15% increase.

The lack of White population growth is concerning and a topic for future TARF Forum discussions. The disproportionate numbers in both Hispanic and Asian population growth demonstrates the impact of the flow of immigrants from south of the US/Mexico border and from the Asian nations via airports.

Before Covid hit the Federal government publicly acknowledged an estimated ten (10) million Illegal Occupants (IOs) are walking free in our borders. Most of them are from the nations south of the US/Mexico border.

It should be noted that in the year 2000, there were already one **(1) million** more Hispanic citizens than Black citizens. But thanks to no border security and Chain migration abuses, by 2020 there were seventeen **(17) million** more Hispanic than Black citizens.

### Summary 2020 US Census Counts by Race

It should be noted that while the previous P45 administration did stop the flow of immigrants through our border Ports-of-Entry, especially pregnant women. They did not stop those just walking across our 1,962-mile border by the thousands. That is the Plain Truth, folks.

Again, both Republicans and Democrats in the US Congress and every President for the last 40 years are equally at fault in failing to secure our national borders. Why? Not so much because Progressives keep screaming to let everybody in! But mainly because politicians know their primary donors want cheap labor and/or more bodies legally or not, to fill-up their rental units. The Plain Truth, again.

That drives down availability and drives up rental housing prices. Ask **Gen-Z** and their older siblings about rental prices, let alone buy a house. That is more today's reality than you may have considered, folks.

That was the background. Now lets fix the Immigration problems.

### **The US Comprehensive Immigration Reform Program (CIRP)**

I will be prompting the Democrats to begin pushing the TARP the CIRP approach in Congress very early in 2026. The Immigration Reform Proposal is far better than the P47s Immigration Chaos. ## **The Sandy Hook Obviously Guilty 90-Day Death Penalty Rule**

aka, *The SHOG Rule.*

This topic is American Agenda Proposal #6 – *Zero Tolerance for Free-Will by All People* from my book CS2.

The Victims' Families and Friends (VFF) of murder victims would definitely be some of the people that will start TARF Local Chapters. And could help us find 2026 Democrat candidates.

This along with immigration are parts of what I refer to as the Public's *slow-burning rage* against our elected officials in both Parties. Sometimes socially and sometimes economically. This is gut level social legislation, folks. The numbers you're about to see are rude and both Parties are equal in blame.

At one-point last summer (2024) statistics told the following story. An average of 55 people is murdered every day (about 20,000 annually) in our nation. The lowest number of murders was 6 and the highest number was 90 in one day!

Over a 9-year period ending in 2023, less than 30 murderers received the Death Penalty annually. Yes, 55 murdered a day and less than 30 executed a year.

The well-intended Liberal/Progressive actions against the things like the Death Penalty (DP) can turn into social and economic mistakes. *Since 1973, at least 200 people have been exonerated from death row in the U.S., according to the Death Penalty Information Center.* And good for them.

The Judicial Legal Complex is making a living off this preventable chaos. And both Democrats and Republicans figure out how to raise donations saying they will "fight" the problem but never fix it. Capitalism finds a way, doesn't it!!

## **Now for reality check from the Men of America – Consider this a Public Service Message**

This ties directly into a never discussed raging problem among all men no matter their color. We are enraged against politicians, lawmakers, lawyers, the courts, and the LAW. Because the LAW prevents us from punishing anyone that murders or rapes or assaults our own family members. We cannot even protect our children for pedophiles in the clergy.

And we men Demand justice and the Death Penalty – NOW!!! And so do most women...

### **Law Without Appropriate Punishment Leads to More Crime**

The American public wants Law that correctly punishes hard voluntary crimes and Order in our community streets. When reviewing that draft proposal with people I included murder and pre-meditated rape not date rape. After talking for a while people would often say to certainly add pedophile crimes to that list. Then I told them it was already in there.

Consider that the public's absolute hatred of pedophiles is why P47 can't just tell is MAGA base to just "forget about it" with his old pedo/BFF. That lower than low life pedophile was either killed or did commit suicide because he knew his days were numbered and his end would not be exactly pleasant!

Secondly, we may need to push for Stable Pump Pricing the could keep prices flat and not moving up and down with the weekends as they often do!!!

Regarding Housing Costs, we will need to undo what I call the *Sins of Our Congressional Fathers and Mothers*.

## 9. How Far is it to the Planet Mars

Today's Space Speed and Our Lack Thereof

I have always wondered about the size of space and the speed-of-light. The speed-of-light in the vacuum of space is 186,282 miles per second.

### **An Informative and Sobering Speed-of-Light Space Fact**

On average it is 140,000,000 miles from planet Earth to Mars. The distance varies depending on where the planets are in their orbits.

At current space speed levels, it would take us **128 to 333 days** to travel from planet Earth to Mars. The variance again is caused by the orbital paths of both planets.
