- 5. Such comm devices do not belong in elementary schools. And it is generally accepted that students should not have routine access to a smart phone before they complete the 8<sup>th</sup> grade. Computers and Cell phones should not be used for childcare purposes. Children need to socialize.

For a personal perspective. I can remember going to school long before cell phones. I went there to learn, to be with my friends, participate in activities, and generally be away from home and my 3 sisters for a while. Not that home was that bad, but it was nice to get away from everything into the closed school environment. Kids today drag all that "outside world" stuff with them and a whole lot more. School is supposed to be for learning and social development.
