

Federal & State Legislators Invade Florida Hospital Room

We the People, Providing the US Congress with Our Demand Legislation

On February 25, 1990 a 41-year-old Florida woman suffered severe cardiac arrest. That, plus related complications left her in a persistent vegetative state. That is, no brain functions. In spite of that dire diagnosis, standard and experimental therapies were administered for three (3) years, and without positive result.

Only after all that, her husband decided to stop any further life-sustaining measures for his wife. Totally rational thinking and his legal right as her husband to decide. However, her parents could not accept the situation and many years of litigation followed. She remained in a coma until passing away, some 15 years later on March 31, 2005.

I will keep this brief, but I ask you to please take a moment and review this write-up.

I ask for everyone to consider an recent example of how rapidly the US Congress actually can pass and enact legislation. How rapidly they can write, debate, pass legislation thru both the US House and Senate, and have the President sign it into law – in a matter of days.

To be clear, the Republican Party owns this particular legislative disaster, but the Democrats were in on it, too.

I, of course made adjustments herein with family names to respect their privacy. I must note here that in my initial writing on this issue, I mistakenly referred to Pennsylvania rather than Florida. Pardon my error.

Her case was kept alive in courtrooms for many years. Jeb Bush, who was then Florida’s governor and a possible 2016 Republican presidential candidate, signed “A Special Florida Law” in 2003 to reinsert her feeding tube after courts had ordered it taken out. Jeb Bush would eventually take it to the Supreme Court and found no help there either. US Congressional legislators attempted to diagnose her condition on the Senate and House floors without having seen her in person. It all ended with President George W. Bush cutting short a vacation at his ranch in Texas to fly back to Washington to sign the legislation that would allow her case to be heard in federal courts. Legislation that the Republicans and Democrats had spent several days arguing over in the House and Senate.

Eventually, the courts agreed with her husband and allowed her feeding tubes to be removed. That included overturning Bush’s, “A Special Florida Law”. She passed on March 31, 2005.

A majority of Americans seemed to say that in a relationship involving physicians and families, politicians should steer clear. According to a TIME poll taken in 2005, 70% of respondents said they *disapproved* of the president’s role in the issue and 54% said they would be more likely to *vote against* their representative in Congress if he or she sided with the president.

As I recall, a Florida member of the US Congress was bounced out of his office the very next election because he publicly protested the husband’s position.

“The will of the people was not for the government to intervene in end-of-life decisions,” Sandeen tells TIME. “When [Sen.] Trent Lott and [Senate Majority Leader] Bill Frist are on the floor diagnosing her, not having ever looked at her as a patient, I think America said, ‘Enough is enough.’”

- We will begin Citizen registration for a US Citizen National ID System. A long overdue facility that practically every other nation in the world has and uses constructively.
- We will register every single person walking about in our nation. We have Legal Occupants (LO) made up of Citizens and other legal/invited persons. And we will register ALL of the Illegal Occupants (IO) that are in our nation. The federal government freely acknowledges that there are some ten (10) million IOs walking around. A total national housekeeping.
- Implement the International Traveler Tracking System (ITTS) to FINALLY begin to control “overstays” that enter our nation with a passport and no intention of leaving any time soon.
