## US Immigration Problem and Solution 2024

### First the Problem – Defined by 25 Republicans Governors on September 16, 2023

Clearly defined in the letter from the Republican Governors Association (RGA) Joint Governors Letter to President Biden on the Impact of the Border Crisis

Dear Mr. President,

The crisis at the southern border extends to every state. As a result of your policies which incentivize illegal immigration, our states are carrying the burden of both the years-long surge in illegal border crossings and cartels' coordinated trafficking of drugs and human beings. States are on the front lines, working around-the-clock responding to the effects of this crisis: shelters are full, food pantries empty, law enforcement strained, and aid workers exhausted. As governors, we call on you to provide honest, accurate, detailed information on where the migrants admitted at the southern border are being relocated in the United States, in addition to comprehensive data on asylum claim timelines and qualification rates, and successful deportations. We ask for this information immediately, but also regularly as the crisis at the southern border continues.

Your administration can no longer ignore simple facts that threaten our citizens' public safety and strain their public resources. Since you have taken office, there have been over 5.8 million illegal crossings at the southern border. In addition, your Customs and Border Protection agency estimates 1.6 million crossers have evaded apprehension. Even illegal crossings at the northern border have increased exponentially under your administration, in some areas by nearly 850%. In the past two years, 244 people on the terrorist watchlist were stopped trying to cross the southern border—an all-time record. Absent transparency from your administration, though, we cannot know how many terrorists have evaded capture and are now freely moving about the country. Your administration admitted under oath to Congress that cartels prioritize the southern border as a major corridor and exploit it daily for human and narcotics trafficking. Our country cannot tolerate 100,000 deaths every year from a fentanyl crisis fueled by cartels pouring the fatal drug into our communities, nor can it tolerate the horrors of human trafficking and the lifelong scars it leaves on victims.

Though we remain committed to addressing these issues, States cannot afford to respond to a challenge of such magnitude while the federal government continues to turn a blind eye. Analysts estimate the annual net cost of illegal immigration for the United States at the federal, state, and local levels is at least \$150.7 billion. States are forced to provide financial, educational, and medical support to migrants entering our country illegally—support that is skyrocketing in cost due to record inflation and the unprecedented influx of migrants into our states. The financial impact on the states is staggering, and it is our hardworking citizens who shoulder that burden.

This is not a partisan issue. Democrat New York City Mayor Eric Adams stated, "This is not a New York City problem. This is a national problem....[Funding for the influx of migrants to New York City is] going to come from our schools' services. It's going to come from our streets. It's going to come from what we provide to children." Our fellow governor, Democrat Maura Healey of Massachusetts, declared a state of emergency due to the number of migrants in her state, and described the federal government's mismanagement of immigration as "a federal crisis of inaction."

As we have made clear repeatedly, every state is now a border state.

As governors, we call on you and your administration to relay immediately accurate, detailed, thorough data and information to the states about who is crossing the southern border illegally, where they are relocating, how the federal government is processing their asylum applications, and whether they are being deported successfully. Without such information, we cannot fulfill our fundamental duties to protect our citizens while providing our communities with appropriate services.

# The US Immigration Reform Solution Part 2

#### The US Census 2000 versus 2020 Population by Racial Breakouts

In Part 1, we reviewed the immigration crisis and it state-level damage it is causing our nation. To put an exclamation mark on it, the following statistics are from the US Census for 2000 and 2020. I found it surprising the first time I saw these numbers. Those of us that are and are not concerned about "white replacement" issues, need to look at this as objectively as possible.

Over those 20 years the:

- White American population increased only, 1.3 million; <u>under 1% increase</u>.
- Black American population increased, 7.9 million, a 22% increase.
- Asian American population increased, 9.4 million; a 93% increase.
- Hispanic American population increased, 23.8 million; a 64% increase.
- Total American population increased, 43.0 million; a 15% increase.

That means 55% of the US population increase over those 20 years was from excessive Hispanic immigration.

Further, for some years, the Federal government publicly acknowledges an estimated ten (10) million Illegal Occupants (IOs) – *the undocumented* are just walking free in our borders. A more recent stat noted that number could now be 15.5 million. *There is no control*, *like no control* – right?

It should be noted that in the year 2000, there were already one (1) million more Hispanic citizens than Black citizens. But thanks to no border security and horrific Chain migration abuses, by 2020 there were seventeen (17) million more Hispanic than Black citizens.

Enough said on that. I believe we all get the Big Picture after that, folks!

# **US National Immigration Reform Proposal**

# "The Suspension of Immigration"

Please note this in the presentation properly refers to the White House and/or Congress taking charge of these actions.

Do understand that for the last 35 years either the White House or the US Congress could have initiated this easy-to-implement solution if they had the political guts to do it. The US House and Senate could pass this legislation and if a President vetoed it – they, could override his veto and make it the law of the land. They have collectively failed to do it for 35 years.

#### This is How it Will Work

I initiate what I refer to the *American Reformation* legislative movement with our *simple-to-implement* and comprehensive US Immigration Reform proposal.

We shall begin telling our Congressional legislators exactly what to do about certain problems. Exactly what the masses Demand to be done. We will now set the legislative tone with true Immigration Reform!

The key points of the National Immigration Reform proposal that we now Demand are:

We will suspend, effective immediately in late 2023, our involvement in any and all treaties protecting random migrants seeking entry into the US. That includes The US Passed Federal Law – Refugee Act of 1980. No exceptions!!

The Governors will in effect, yet unofficially, declare the Suspension of all Treaties when they announce their borders will be closed to all migrants – on or before December  $31^{\rm st}$ . DC will in time take care of the paperwork.

We will strongly suggest, if not Demand that the "courts" will not entertain any law suits attempting to delay the border closures. The border closures will not be delayed by some ridiculous court order. We will ignore them.

- 2. We will close the US/Mexico border to all migrants as early as October 31, 2023 and no later than December 31, 2023. And the People will rejoice!
- 3. Closing of all Land border Ports-of-Entry, thru at least 2025.
- 4. The White House will inform Mexican President Obrador, as well as the leaders of all Central and South American nations that we are closing the door, with no exceptions.

The Governors will in effect, be indirectly informing President Obrador when they issue the border closing notifications.

I think it safe to say that Obrador will get a copy of this one way or another!

Obrador will need to block Mexico's southern borders with Guatemala and Belize. To actually stop the flow. No more migrants on north-bound trains. By December 31, 2023 the door will be closed and Mexico will retain any and all remaining migrants – to do with as they please!

President Obrador will also need to stop the illegals flowing into Mexico's international airports and then across the US/Mexico border. Needless to say, our immigration suspension policy will be worldwide news and any potential migrants will know about it.

By the way, President Obrador publicly denies that raw Fentanyl flows from China to Mexican cartels for processing and is then smuggled across the soon to be guarded 24/7 border.

Currently, between 200 to 300 American men, women, and teenagers are overdosing and dying – from the Fentanyl that is too easily transported across the US/Mexico border.

To me that is equivalent to 200 to 300 "daily" long distance intentional shots across our southern border that find they're into the live bodies of men, women, and teenagers in all fifty states. AND KILLS THEM!

# For the Governors, the remainder of this will fall to DC once all of this inevitably comes together by early 2024.

- 5. No more "Chain migration" claims will be processed thru at least 2025. Such claims now in process will be cut-off, ASAP. Closing that much abused back door.
- 6. Going forward, potential migrants will need to register at US Embassy in their own country. Employment would be coordinated via Embassies and if approved, a US Entrance Pass will be issued.
- 7. Immediate 24/7 guarding of the entire 1,962-mile US/Mexico border. And to a lesser degree on the US/Canada border, as well. Canada does not encourage the migrant flow like Mexico does for fun and profit. Go Canada!
- 8. We will begin US Citizen registration for a US National ID System. A long overdue facility that practically every other nation is the world has and uses constructively. Consider that America is like a warehouse with over 330,000,000 parts and not one of them as a product code and/or part number. Chaos...
- 9. We will also register every other person walking about in our nation. We have Legal Occupants (LO) made up of Citizens and other legal/invited persons. And we will register ALL of the Illegal Occupants (IO) that are in our nation. A total national housekeeping exercise. And we will determine what to do with them.
- 10. Implement the International Traveler Tracking System (ITTS) to finally begin to control "overstays' that enter our nation via international airports with a passport and no intention of leaving any time soon. Again, the government acknowledges that more IOs enter our nation via airports then via the Southern border! The Congress never seems to talk about that? And the airlines will be required to support that ITTS Passenger Registration system. The airlines have fought such procedures for decades. So much for national security...

11. Finally, we are not building another ridiculous foot of US/Mexico border wall. One day we may in fact "tear down that wall" and recycle as much of it as possible.
