The Kansas City Super Bowl Parade Shooter Meets the Sandy Hook Obviously Guilty 90-Day Death Penalty Rule

We the People, Demand that the Death Penalty (DP) administered via pill or lethal injection be brought back into active and aggressive nationwide use. The People's justice will be applied to a few heinous free-will crimes. More crimes will be added to the list.

This SHOG Rule will be applied – whether or not an insanity plea is approved or not. Of course they are insane. However, if they killed someone once – they will also die!

This approach will likely earn the nickname of, "one and done" and the SHOG Rule, of course.

The Prime Civil Offense – **Murder**. The grim mass-murder at Sandy Hook Elementary School is the spiritual name for this legal Reform. It applies to all the ways of taking one or more lives. With a gun, knife, bare hands, brick or a #4 pencil – murderers will pay for their actions and sooner rather than later.

I was both personally surprised and disgusted when I researched the current human numbers behind the Liberal movement against use of the Death Penalty. It began honestly as a movement to prevent innocent people from being falsely accused, convicted, and executed. That is only right. However, over the years it mutated into a "no death penalty" movement, which has done far more harm than good. Unfortunately, today some 40 states no longer allow it at some level.

Now for human numbers.

A recent national statistic shows that on average some 44 of our fellow citizens are murdered every day in America! Unbelievable! The lowest one-day body count is six (6) and the highest is ninety (90). An incredible waste of people.

So, let's go with 44 murders-a-day times 365 days-a-year equals 16,060 murders per year on average. So just for the sake of this discussion let's say 50% or 8,030 should have received the DP for their heinous actions. Key words there were "should have".

In the year 2022, 18 death row inmates were executed in the United States.

2023 is the 9th consecutive year with fewer than 30 people executed (24) and fewer than 50 people were sentenced to death (21). Also, unbelievable!

The stats according to the Death Penalty Information Center.

It is certainly making those that run jails and prisons for profit, a steady fortune.

As I will review below, the Marjory Stoneman Douglas High School shooter in Parkland, Florida slaughtered 14 students and 3 adults and received 17 life sentences, only 3 sentences were without the possibility of parole. No Death Penalty was granted because the jury could not reach a unanimous verdict on it. Under SHOG, the jury will finally be totally removed from the decision process in these cases.

To be clear, a nation where someone can act to kill 17 human beings, with 14 of them being students and not receive a swift death penalty execution – is a nation without Justice. Starting with the Kansas City Parade shooter, We the People, Demand the SHOG Rule for such murderers.

We will act to reverse this initially well-intended effort that is now doing far more harm than good for our society.

Further, I personally believe we must consider that the SHOG Rule could even be applied retroactively in many active cases. Many cases that are in process and even some already closed. Time will tell. Granted this common-sense Reform will bring on a furious and loud public outcry by the Screamers, Progressive Democrats, and the lawyers. That will soon pass. Again, at least 65% of Americans are fed-up with our current in-Justice system.

Finally, we will need to begin consolidating and working on shutting down all Maximum-Security Prisons (MSP). Further, in the case of Sandy Hook Elementary School, 6 school women teachers also lost their lives and their loved ones had to deal with that sudden tragedy. And while they were grown adults when their lives were taken too early – those parents still had to bury their own dear children. Such tears.

Then on February 14, 2018 there was Marjory Stoneman Douglas High School – Parkland, FL
