RECEIVER'S FIRST QUARTERLY REPORT FOR RECEIVERSHIP ESTATES

Deborah D. Williamson, in her capacity as the Court-appointed Receiver (the "Receiver") for the Receivership Parties (as defined in the Court's December 2, 2021 *Order Appointing Receiver* [ECF No. 17] and receivership estates (collectively, the "Estates") in the above-captioned case (the "Case" or "Receivership"), hereby files this *Receiver's First Quarterly Report for Receivership Estates* (the "Report"). The *Order Appointing Receiver* [ECF No. 17] (the "Receivership Order") requires the Receiver to file a report within thirty (30) days of the end of each calendar quarter. Reasonable efforts have been made to fairly and accurately summarize the current status of the Receivership but any summary, of necessity, will omit details. The Receiver will be available to attend a status conference or otherwise respond to the Court's questions at the Court's request.

I. <u>BACKGROUND</u>

- 1. On December 1, 2021 (the "Application Date"), the Securities and Exchange Commission (the "SEC" or the "Commission") filed its *Emergency Motion for a Temporary Restraining Order and Emergency Ancillary Relief* [ECF No. 3] which included an application for the appointment of a receiver for the Receivership Parties (the "Application").
- 2. On December 2, 2021, this Court determined that entry of an order appointing a receiver over the Receivership Parties was both necessary and appropriate to marshal, conserve, hold, and operate all of the Receivership Parties' assets (the "Receivership Assets") pending further order of this Court. Accordingly, the Court entered the Receivership Order on December 2, 2021, appointing Deborah D. Williamson as the Receiver over the Estates in this Case [ECF

No. 17]. That same day, the Court entered the *Order for Temporary Restraining Order and Other Emergency Relief* [ECF No. 12] (the "TRO"), and the *Asset Freeze Order* [ECF No. 14].

3. Pursuant to the Receivership Order, the Receiver is charged with:

marshaling and preserving all the assets of the Defendants (the "Receivership Assets") and those assets of the Relief Defendants that: (a) are attributable to funds derived from investors or clients of the Defendants; (b) are held in constructive trust for the Defendants; (c) were fraudulently transferred by the Defendants; and/or (d) may otherwise be includable as assets of the estates of the Defendants (collectively, the "Recoverable Assets").

Receivership Order at 2.

4. Additionally, the Receivership Order provides:

Within thirty (30) days after the end of each calendar quarter, the Receiver shall file and serve a full report and accounting of each Receivership Estate (the "Quarterly Status Report"), reflecting (to the best of the Receiver's knowledge as of the period covered by the report) the existence, value, and location of all Receivership Property, and of the extent of liabilities, both those claimed to exist by others and those the Receiver believes to be legal obligations of the Receivership Estates.

Receivership Order at 19 ¶ 56.

- 5. The Quarterly Status Report is directed to contain the following:
 - A. A summary of the operations of the Receiver;
 - B. The amount of cash on hand, the amount and nature of accrued administrative expenses, and the amount of unencumbered funds in the estate;
 - C. A schedule of all the Receiver's receipts and disbursements (attached as Exhibit A to the Quarterly Status Report), with one column for the quarterly period covered and a second column for the entire duration of the receivership;
 - D. A description of all known Receivership Property, including approximate or actual valuations, anticipated or proposed dispositions, and reasons for retaining assets where no disposition is intended;

- E. A description of liquidated and unliquidated claims held by the Receivership Estate, including the need for forensic and/or investigatory resources; approximate valuations of claims; and anticipated or proposed methods of enforcing such claims (including likelihood of success in: (i) reducing the claims to judgment; and, (ii) collecting such judgments);
- F. A list of all known creditors with their addresses and the amounts of their claims;
- G. The status of Creditor Claims Proceedings, after such proceedings have been commenced; and
- H. The Receiver's recommendations for a continuation or discontinuation of the receivership and the reasons for the recommendations.

Receivership Order at 19–20 ¶ 57.

6. As stated above, the Receiver was appointed on December 2, 2021. Accordingly, this First Quarterly Report officially covers the twenty-nine day period of December 2, 2021 through December 31, 2021 (the "Reporting Period"). Certain information or activity subsequent to December 31, 2021 is also included for context and/or completeness.

II. GENERAL OVERVIEW

7. The Receivership Parties are generally in the business of investing in, purchasing, operating and producing certain oil and gas assets. Certain Receivership Parties also own real estate, aircraft, and other property. The Receiver has actively recovered, inventoried, and investigated assets and liabilities of the Receivership Estates. The Receiver has taken possession of two aircraft, three light use trucks, multiple pieces of oil field and construction equipment, real property, Dallas Cowboy tickets, a salt water disposal operation, and hundreds of operating and non-operating wells. The Receiver has obtained and preserved hard and electronic data from multiple locations controlled by one or more Receivership Parties, their former counsel and in Panama. The Receiver also analyzed thousands of documents. The Receiver has interviewed

certain principals of the Receivership Parties. The interview process is on-going. As outlined below, the gathering and review of documents and electronically stored information is on-going. The Receiver has worked with various counsel, including, but not limited to her lead counsel, Dykema Gossett PLLC ("Dykema"), Rose Romero with Romero Kosub and Darrell Jones with the Law Offices of Darrell R. Jones in an attempt to locate assets for distribution. The Receiver has coordinated with the SEC to avoid duplication of production of documents and interviews. Many of the tasks performed by the Receiver apply equally to each of the Receivership Estates. Accordingly, the statements and reports contained within this First Quarterly Report should be read to apply equally to each of the Receivership Estates, except where specifically noted to apply to a specific Receivership Estate.

8. One or more of the Heartland Parties raised tens of millions of dollars in the form of short term promissory notes and equity investments ultimately for the benefit of the Defendants and/or the Relief Defendants. The holders of those notes and equity investments are generally referred to as "creditors" and/or "investors" in this Report.²

III. <u>REPORT</u>

A. INITIAL LOCKDOWN

- 9. At the commencement of the Reporting Period and upon the Receiver's appointment, the Receiver took swift action to maintain the *status quo* and preserve the Receivership Estates. Some of the actions the Receiver and her team took included:
 - a. Serving Mr. James Ikey ("<u>Ikey</u>" or "<u>Mr. Ikey</u>") with the Receivership Order, TRO, and Asset Freeze Order, and recovered Alternative Office Solutions, LLC ("<u>AOS</u>") cell phones, servers, and laptops;

- b. Serving the Receivership Order, TRO, and Asset Freeze Order on the pilot and operators of the hangar where two aircraft (described more fully below) were recovered;
- c. Serving an employee at the office located at 1426 US 380 Bypass, Graham, Texas (the "<u>Graham Office</u>") with the Receivership Order, TRO, and Asset Freeze Order; employing locksmith to change locks on front gate to prohibit access to the surrounding yard (the "<u>Graham Yard</u>"), as well as changing locks on the Graham Office, and subsequently changing the locks on the residence attached to the Graham Office (the "<u>Graham Residence</u>") (collectively, the "<u>Graham Property</u>"); recovering computers, servers, and documents from Graham Office;
- d. Recovering electronics from the headquarters of The Heartland Group Ventures LLC ("<u>Heartland Ventures</u>"); Heartland Production and Recovery LLC; Heartland Production and Recovery Fund LLC; Heartland Production and Recovery Fund II LLC; The Heartland Group Fund III, LLC; The Heartland Drilling Fund I; LP Carson Oil Field Development Fund II, LP; Dodson Prairie Oil and Gas LLC; and Panther City Energy LLC (collectively, the "<u>Heartland Parties</u>") located at 777 Main Street, Suite 2160, Fort Worth, Texas (the "<u>Heartland Fort Worth Office</u>"); and changed locks on office;
- e. Recovering three light-use pickup trucks from Mr. Ikey and Rustin Brunson ("<u>Brunson</u>") on behalf of Heartland Ventures; and
- f. Other actions, described more fully below.

B. SUMMARY OF ACTIVITIES

10. Immediately upon being appointed, the Receiver took possession of or obtained access to certain locations, including the Heartland Fort Worth Office; the Barron Petroleum LLC ("Barron Petroleum"), Leading Edge Energy, LLC ("Leading Edge"), Dallas Resources Inc. ("Dallas Resources") and Arcooil Corp. ("Arcooil") offices in Graham, Texas (previously defined as, the "Graham Office") as well as the Graham Yard; the ranch in Eldorado, Texas³ (occupied by Roger Sahota, his wife, Harprit, and his son, Monrose) (the "Dallas Resources's Ranch"); and

Dallas Resources's home in San Angelo, Texas⁴ (occupied by Sunny Sahota and his family) (the "San Angelo House"). Shortly, thereafter, the Receiver took possession of the Graham Residence. The Receiver did so by changing the locks on the doors, as well as photographing those locations, and beginning an in-depth inventory of all assets located in each location. The Receiver also authorized a change of locks on a ranch located off Highway 99 in Palo Pinto County, Texas (the "Palo Pinto Ranch"). Additionally, on December 7, 2021, the Receiver obtained unfettered access to the AOS office located at 400 Industrial Blvd., Suite 202, Mansfield, Texas 76063, when Ikey provided the Receiver with the office keys and the alarm code. Unable to determine the leaseholder of that property and based on Ikey's willingness to cooperate with the SEC and the Receiver, the Receiver chose not to change the locks on that location but did photograph and inventory the office.

a. Dallas Resources's Ranch and the San Angelo House

11. On December 3, 2021, immediately following the Receiver's appointment, two attorneys from Dykema's San Antonio office, accompanied by a U.S. Marshal and other law enforcement, went to the Dallas Resources's Ranch in Eldorado, Texas, and the San Angelo House. During those on-site visits, the U.S. Marshal served all the Sahota parties other than Relief Defendant Monrose Sahota. The Dykema attorneys also took possession of 23 boxes of papers, files, cash, computers, phones, and easily portable and potentially valuable objects. Relief Defendant Sunny Sahota claimed to not know the password for his iPhone.⁵

b. Graham Property

- 12. Also, on December 3, 2021, an attorney from the Dykema Dallas Office went to the Graham Property, the alleged operations center of one or more of the Sahota Parties.⁶ He met a locksmith at the location who changed the locks on the office, as well as the lock on the gate surrounding the property. Possession was taken of computers, phones, and additional documents. Passcodes and logins were also obtained from a person working at that location.
- 13. On December 7, 2021, a second visit to the Graham Property was made with the primary purpose of changing the locks to the residence adjacent to the office. Within the Graham Residence, attorneys from the Dallas Dykema office photographed the residence and recovered easily transportable, valuable items including a coin collection, watches, jewelry, phones, and other potentially valuable documents. Additionally, the Dykema attorneys further reviewed documents in the Graham Office and recovered documents necessary for the Receiver's operation of the Receivership Parties, including insurance documents, additional logins and passwords, accounting and bank records, and employee files. Furthermore, while collecting mail from the mailbox, the Dykema attorneys were approached by an individual who stated he was a personal injury litigant with a lawsuit against Barron Petroleum and Arcooil. This individual also noted that there had been equipment on the lot as of the prior Wednesday, December 1, 2021.

complicated for Defendant Manjit Singh (Roger) Sahota and Harprit Sahota. The SEC had been unable to identify any bank accounts in their individual names. Subsequently, the Receiver received account information regarding a credit card of Mandeep Sahota but also in the name of Arcooil, a Receivership Party. The account is also tied to the cards used by Defendant Roger Sahota and Relief Defendants Harprit, Sunny and Monrose Sahota. The Receiver is investigating whether this account is the subject of the Receivership Order.

- 14. Upon further inquiry, the Dykema attorneys discovered that multiple pieces of oil and gas equipment and vehicles had been towed from the Graham Yard to a nearby tow facility operated by Big Dog Towing in Graham, Texas, just before the Receiver was appointed. After analyzing the cost of continuing to store the equipment at Big Dog Towing versus the costs of transporting the equipment back to the Graham Yard,⁷ the Receiver decided it would be more economical to have the equipment towed back to the Graham Property. The Graham Property is also being used to store other equipment. A Dykema attorney from the Dallas office oversaw the towing of this equipment back to the Graham Property on December 21, 2021. Once the equipment is disposed of, the Receiver will seek to sell the Graham Property.
- 15. On December 16, 2021, two attorneys from the Dykema Dallas office went to the Graham Property to transport documents recovered from the Heartland Fort Worth Office regarding the gas wells to the Graham Property to be stored with other well documentation. Additionally, the Dykema attorneys recovered six (6) file boxes and additional baskets of operational documents to take back to the Dykema Dallas office to be analyzed and used by the Receiver in operating the Receivership Parties going forward.

c. The Heartland Fort Worth Office

16. On December 3, 2021, the Receiver went to the Heartland Fort Worth Office, which was the headquarters of the Heartland Parties. The Heartland Parties, through Defendant Rustin Brunson, have been cooperative. The Receiver had the locks changed at the Heartland Fort Worth

Office, conducted a preliminary inventory, and removed certain documents, computers, and phones.

17. On December 8, 2021, an attorney from the Dykema Dallas office met the Receiver at Heartland Fort Worth Office, to finish the inventory in the offices, photograph the furniture to assist in its future sale, and to obtain the mailbox key and the mail. Since this time, Mr. Jeff Fine, one of the Receiver's counsel at Dykema, has negotiated with the 777 Main Street's landlord and Jackson Walker ("JW"), which already rents the remaining offices on the same floor to surrender the Heartland Fort Worth Office and waive any current or future rent. 777 Main Street's landlord, JW and the Receiver are seeking this Court's approval of the agreements. This settlement will release the Receivership Estates from any liability related to the offices under the lease including liability which arose after the appointment of the Receiver and a payment of approximately \$10,000 to the Receivership Estates. The settlement was approved on January 31, 2021.

d. AOS Office

AOS office in Mansfield, Texas. They served Mr. Ikey, Relief Defendant Bridy Ikey ("Mrs. Ikey"), Relief Defendant Encypher Bastion, LLC, and IGroup Enterprises, LLC, and AOS (collectively, the "Ikey Parties") and also obtained documents, laptops, cellphones, and other information. Mr. Ikey informed the Dykema attorneys that there were 19 boxes of wine⁸ that constitute Receivership Property, as well as computer towers. The Dykema attorneys were unable to seize these items at that time due to their vehicle's capacity. Additionally, it was discovered

later that Ikey, and Mrs. Ikey had each failed to deliver a phone to the Dykema attorneys. Those phones have now been recovered by the Receiver and will be imaged.

- 19. A second visit was made to the AOS office on December 7, 2021, by two attorneys from the Dykema Dallas office. On that visit, the Dykema attorneys took into their possession another of Ikey's cell phone, as well as 11 computer towers previously identified as AOS property. Additionally, the attorneys requested that Ikey turn over the keys and title to his pickup truck, which had been identified as Receivership Property. The Dykema attorneys took the keys to Ikey's truck. The truck was ultimately moved to Fort Worth.
- 20. A third visit by two attorneys from the Dykema Dallas office was made to the Ikey Parties on December 13, 2021. The Receiver discovered that Mrs. Ikey still held a cellphone in her possession that needed to be recovered and imaged. This third visit to the Ikey Parties by Dykema Attorneys began at the 103 Bayonne Drive, Mansfield, Texas ("Ikey's Home"). Mrs. Ikey's phone and Heartland Parties' account checkbooks were recovered. Ikey also turned over a set of keys and alarm codes to the AOS office, keys to the storage unit containing the jade, and an additional storage unit with AOS furniture.
- 21. The two attorneys left the Ikey's Home and went to the AOS office, where they recovered an additional AOS laptop, AOS and other Receivership Party documents, and flash drives. Additionally, the title to Ikey's truck was found in a file folder. Next, the Dykema attorneys went to the storage unit housing the jade but were unable to get in because they were provided the wrong key by Ikey. They also went to another additional storage unit at 1587 FM

157 Mansfield, Texas 76063 and inventoried contents that included office equipment and a miniature oil rig figurine.

e. Electronically-Stored-Information ("ESI")

- 22. The Receiver has attempted to maintain a chain of custody of the information and electronics received from any Receivership Party. Maintaining a secure chain of custody is particularly important with data which is electronically stored. In furtherance of this litigation, the SEC has agreed to attempt to "image" or otherwise capture the information ("ESI") on all electronic phones, laptops, computers, servers, tablets, thumb drives, etc. This process will be elaborated on further herein *infra* Section E, *Receivership Property*.
- 23. In addition to preserving the ESI discovered at all the locations, the Receiver locked down and changed passwords to various online accounts controlled or maintained by Receivership Parties. Additional accounts and passwords are regularly being recovered. Locking down and changing passwords is an ongoing process.
- 24. The Receivership Parties stored much of their information on a server in Panama, through Encrypt Fortress (https://encryptfortress.com/). Upon entry of the Receivership Order, the Receiver requested that the information be fully turned over as it was not under her control. The Receiver filed an Application to Employ BDO USA, LLP ("BDO") as forensic expert and investigative consultant effective as of December 23, 2021 [ECF No. 65]. BDO has focused its efforts on preserving the ESI located on the server in Panama and processing and hosting that ESI.

f. Information held by Receivership Parties' Prior Counsel

- 25. Paragraph 47 of the Receivership Order gives the Receiver the power to "waive, all privileges, including the attorney-client privilege, held by all Receivership Parties." [ECF No. 17 at 17 ¶ 47]. The Receiver's counsel has sent letters to the Receivership Parties' prior counsel that: (1) requests they return any Receivership Property, such as retainers; (2) directs them to the provision in the Receivership Order dismissing these attorneys from any further representation of any of the Receivership Parties; (3) requests preservation of all paper and electronic information of or relating to the Receivership Parties; (4) requests preservation of any data, electronic communications, or electronic devices etc.; and (5) requests turnover of all attorney Receivership Party files, whether maintained as paper files, electronic files, or otherwise, including those files containing otherwise privileged communications between the attorneys and Receivership Parties.
- 26. Requests have been sent to Holland & Knight LLP, Locke Lorde, LLP, Gray Reed & McGraw, LLP, Weintraub Law Group PC, and Fay Matsukage from Doida Crow Legal. Additional requests are on-going as counsel are identified. Locke Lord, LLP, Gray Reed & McGraw, LLP, and Holland & Knight LLP have begun producing records. Gray Reed & McGraw, LLP asserts that it also possesses records which are subject to Ikey's attorney-client privilege. The Receiver's counsel is attempting to reach an agreement regarding production by Grey Reed & McGraw, LLP. If prior counsel does not fully comply with the Receiver's requests, the Receiver intends to seek intervention from the Court.

g. Asset Freeze Order and Bank Accounts

27. As required by the Receivership Order, the Receiver served copies of the Asset Freeze Order on all known financial institutions to institute a freeze on any bank accounts that are (or contain assets traceable to) the Receivership Assets and to obtain transfer of Receivership Party account balances to the Receiver's bank accounts. Ultimately, the Receiver recovered or froze

approximately \$2,298,000 in funds in accounts located at Wells Fargo Bank, Plains Capital Bank, JP Morgan, Chase, First Financial Bank of Abilene, First State Bank of Graham, First National Bank of Eldorado, and Bank of Jackson Hole (collectively, the "Receivership Party Banks"). Of the funds frozen, the Receiver has received approximately \$347,992.78 by the end of the Reporting Period and deposited those funds into the Receiver's new accounts.

- 28. As of the filing of this Report, the Receiver has received a total of \$2,248,402.17 from the Receivership Party Banks. Upon information and belief, the only encumbrances on cash on hand relate to taxes and other governmental claims and potentially royalty obligations.
- 29. The following are bank accounts of Receivership Parties that the Receiver has identified.

- 30. The Receiver requested production of all account statements at the time each bank was served with the Receivership Order. The Receiver may serve additional requests or subpoenas upon the discovery of additional financial institutions that may have accounts related to the Receivership Estates. In total, the Receiver received account information from seven (7) separate financial institutions. Supplemental document production continues on a rolling basis and the Receiver will analyze such information to locate, preserve, and obtain assets belonging to the Receivership Estates.
- 31. The Receiver searched the physical records recovered from the AOS office, the Heartland Fort Worth Office, the Graham Property, multiple storage facilities, the Dallas Resources's Ranch and the San Angelo House, interviewed former contractors and/or employees, and searched electronic data to gather information about oil and gas interests owned or controlled by the Receivership Parties.

h. Feeder Funds

32. Originally, the Heartland Parties raised funds using a "finder" model which raised funds directly from individual investors. In 2019, the Heartland Parties shifted from raising investor funds using finders to a "feeder fund" model. A "feeder fund manager" (an individual

who is typically an insurance agent or financial advisor, and often someone who had previously acted as a Heartland finder) solicited prospective investors through a company formed for the purpose of soliciting investments in the Heartland Parties. The Heartland Parties provided feeder funds with Heartland Private Placement Memorandums ("PPMs") for their offerings, as well as drafting feeder fund PPMs, which mirrored the Heartland Parties' offering document, for use with prospective investors. The Receiver has identified the feeder funds and the principals behind the funds.

i. Receivership Parties' Accounting Records and Business Operations

33. The Receiver identified a need for recovery and maintenance of accounting records including allocation of any production payments to third parties, *e.g.* royalty owners. This process was complicated by the fact that the AOS¹⁰ and Heartland Parties records used Quickbooks which required access through a specific computer, WolfePak which required specific credentials and/or were stored in Panama. The Sahota Parties also used WolfePak and Quickbooks which again required specific credentials. After the Reporting Period and to address these issues, the Receiver sought and obtained approval from this Court to engage Vicki Palmour Consulting LLC ("Palmour Consulting"). After the Reporting Period, Palmour Consulting obtained access to both WolfePak accounts. The Receiver is still attempting to access the various Quickbook accounts for all entities. Similarly, the Receiver is still attempting to access the Microsoft related accounts of the Sahota Parties. While the majority of the records from Panama have recently been retrieved, the Receiver has not begun to review the same.

34. The Receiver also began to review and analyze the available accounting records for all Receivership Parties. Preliminary indications are the books and records may be incomplete. It is possible the Receiver may need to engage a forensic-accounting expert to perform a tracing analysis. The Receiver engaged Palmour Consulting¹¹ but may need to employ additional professionals to assist with other matters beyond bookkeeping and the preparation of the required regulatory reports including the Texas Railroad Commission ("RRC"), the SEC, and the IRS.

i. Insurance

35. The Receiver has identified some insurance policies for the Receivership Parties and requested invoices from various agents or brokers to ensure that insurance will continue to be paid to prevent any further lapse in coverage. The Receiver continues to receive additional information and documentation related to existing and/or potentially lapsed coverage.

C. CASH ON HAND/ADMINISTRATIVE EXPENSES

- 36. During the Reporting Period, the Receiver located accounts and statements as identified in the chart supra ¶ 27.
- 37. Certain administrative expenses, including, but not limited to, rent related to storage units, utilities, field personnel, aircraft appraisal fees (\$6,000), hangar and maintenance costs for the Aircraft (as defined below), COGO (as defined below), court filing and recording fees, license fees, including, but not limited to, WolfePak, transportation and towing fees, auction-related fees, and professional fees (to the extent allowed by the Court) have been incurred by the Receiver. For example, the Receiver has incurred expenses for her legal counsel that has worked diligently during the Reporting Period to address the myriad of issues that have arisen including, but not

limited to: (1) seizure of assets; (2) investigation of assets and causes of action; (3) negotiations with landlords; (4) activities related to the sale of assets, including aircraft and other preparation for disposition of the Estates' assets; and (5) other related matters. The Receiver also incurred some expenses relating to the preservation of ESI. For example, Dykema purchased "faraday bags" and cases to protect ESI from being affected remotely. The Receiver incurred shipping costs to send certain ESI to the SEC for forensic imaging. Many of those costs were initially paid by Dykema, subject to seeking reimbursement from Receivership Assets.

- 38. Receivership Parties also continue to incur monthly expenses in the ordinary course such as rent to the storeroom, landlords, electricity, telephone, internet services, "pumpers" and other monthly charges.
- 39. To date, the Receiver has been able to ascertain the following monthly and/or recurring payments of various Receivership Parties:

42. While certain recurring expenses (e.g., rent obligations) have accrued during the Reporting Period, the Receiver made disbursements related to leases for storage units, payment to

a pumper, and other operating costs. As required by the Receivership Order, the above information in the Receipts and Disbursements chart attached hereto as **Exhibit A**.

E. RECEIVERSHIP PROPERTY

43. One or more of the Receivership Parties owned the jet, helicopter, season tickets and licenses for Dallas Cowboys tickets and other events at AT&T Stadium, a collection of jade figurines, real estate (foreign and domestic), oil and gas properties in at least Archer, Sutton, Crockett, Palo Pinto, Jack, Hardeman, Rusk, Stephens, Wichita, Val Verde, and Schleicher Counties with hundreds of wells, vehicles (including vehicles originally in the possession of Mr. Brunson and Ikey), at least two drilling rigs, working interests, equipment, production payments, checks, and cash on deposit.

a. ESI and Documents

- 44. The Receiver has attempted to maintain a chain of custody of the information and electronics received from and/or recovered from any Receivership Party or Asset Freeze Party. A list of the electronics recovered thus far is attached hereto as **Exhibit B**. Maintaining a secure chain of custody is particularly important with data which is electronically stored. In furtherance of the litigation, the SEC has agreed to attempt to "image" or otherwise capture the information of all electronic phones, laptops, hard drives, tablets, thumb drives, servers, *etc*. It was decided that efforts would be made to (a) keep a "charge" on those electronics which had a charge when taken into custody and (b) prevent remote "wiping" of electronics through safe storage. The Receiver and the SEC prioritized one phone of Ikey's that he asserted held irreplaceable pictures of his grandchildren. This phone has been returned to Ikey.
- 45. December 18, 2021 through December 23, 2021, the SEC sent a vendor to image the larger electronics in the San Antonio Dykema Office and the Dallas Dykema Office. The vendor was unable to fully complete the imaging process and took several laptops and hard drives

from the Dallas Dykema Office. Smaller cell phones, tablets, and laptops for which the vendor was unable to complete the imaging process on site at the Dykema San Antonio office were shipped to the SEC or its designated vendor via a secure method. Furthermore, additional smaller cell phones and tablets remain in the Dykema Dallas office that need imaging, and the Receiver is in the process of coordinating secure shipment of those devices to the SEC and/or its designated vendor for that process.

- 46. Additionally, the Receiver is in the process of discussing with the SEC an efficient method of identifying documentation which (i) needs to be scanned or (ii) which should be left solely in hard copy (at least initially). Additionally, Dykema has created a Relativity Epiq platform to store documents scanned and/or imaged so that the documents can be easily reviewed, tagged, and organized for optimal efficiency.
- 47. One or more of the Ikey Parties provided "back office" accounting and administrative service to one or more Heartland Parties. As part of those "back office" services, one or more agreements were allegedly entered into with Encrypt Fortress based in Panama. These agreements allegedly include servers which house all of Heartland investor data and accounting records. It is the Receiver's preliminary opinion that the agreements were not "market" and may include payments unrelated to services to Heartland Parties. Prior to filing the Complaint, the SEC had requested that the information belonging to any Heartland Party or any Ikey Party be produced. Upon entry of the Receivership Order, the Receiver requested that the information be fully turned over as it was now under her control. In January, BDO obtained what has been represented to be full images of any servers containing data related to one or more Receivership Parties. BDO is in the process of completing transfers of all available back-up data.

48. The Receiver has not been able to access the Quickbooks accounts for the Heartland Parties, the Ikey Parties, or the Sahota Parties. The Receiver was provided the login information for the Quickbooks account for the Ikey Parties but subsequently discovered that the Ikey Parties did not have an online subscription and that QuickBooks could only be accessed from one particular laptop. That laptop, however, had already been sent to the SEC for imaging. The Receiver has encountered a similar situation with the Sahota Parties and cannot access the records without being on a specific computer that is not currently in the Receiver's possession.

b. Aircraft

- 49. On December 3, 2021, an attorney from the Dallas office of Dykema went out to Sherman, Texas and recovered: Canadair LTD CL-600-2B16 (the "Jet") and Agusta SPA A109S (the "Helicopter") (together, the "Aircraft"). A decision was made to re-locate the aircraft to a hangar with restricted access. The current cost of the hangar is \$2,000 a month per aircraft. Additionally, to maintain the value of the Aircraft, the engines must be maintained and there are running, maintenance, and tracking/reporting costs associated with that process. Each month the Aircraft will need to be pulled out of the hangar, turned on, and the engines run for approximately 20 minutes, which needs to be tracked in the maintenance logs. For the Jet, the maintenance needs to be reported so that the engines remain on the engine maintenance contract.
- 50. At least 3 parties have already indicated an interest in purchasing one or more of the Aircraft. If possible, the Receiver would prefer to avoid the costs of a broker. The Receiver currently believes that the most efficient way to sell the aircraft is through a private sale rather than incur the broker's fees and time costs associated with the broker sale process. The Receiver has considered proposals from two appraisal companies, and of those candidates selected, Jeff Durrough, appears to be qualified, local, the least expensive, and able to deliver the appraisals on an expedited basis. Mr. Durrough is the Vice President of Asset Management at the Mente Group

in Frisco, Texas, and is also an accredited ASA appraiser by the American Society of Appraisers in the field of Machinery and Technical Specialties with a focus on Business Aircraft. The Receiver anticipates filing a motion seeking approval of the jet in early February.

c. Real Estate

- i. Dallas Resources's Ranch and the San Angelo House
- 51. Dallas Resources's Ranch is a "ranch" located in Eldorado, Texas, ¹⁴ which is owned by Dallas Resources Inc. and occupied by Defendant Manjit Singh (aka Roger) Sahota, Relief Defendant Harprit Sahota, and Relief Defendant Monrose Sahota. The Receiver has allowed Mr. and Mrs. Sahota and their son, Monrose to remain on the premises after receiving evidence of current insurance. The San Angelo House is a house in San Angelo, Texas, ¹⁵ currently occupied by Relief Defendant Sunny Sahota, his wife, and their 3 minor children. The Receiver has also allowed them to remain on the premises after receiving evidence of current insurance. However, it is the intent of the Receiver to hire a broker to sell both pieces of real estate, subject to Court approval, in the near future. The Receiver has not identified any liens against either

property. A partial and preliminary inventory of Receivership Property is attached hereto as **Exhibit C**.

ii. Bahamas Properties

52. There are at least two (2) properties in the Bahamas (and potentially a third, or an option on a third, piece of property). At least one of the properties is listed on VBRO.¹⁶ Funds related to the acquisition of the Bahamian properties (and/or the option) can be traced to a Receivership Party. The Receiver is attempting to ascertain what entities have title to the Bahamian properties. She has requested that the Sahota Parties cooperate in transferring control and title to the Receiver. Absent a consensual agreement in the very near future, the Receiver may seek assistance of this Court.

iii. Heartland Fort Worth Office

53. The Receiver negotiated the termination of the lease at the Heartland Fort Worth Office located at 777 Main Street, Suite 2160. The Receiver's goal is to sell the office equipment located at the Heartland Fort Worth Office and vacate that property as soon as possible upon Court approval. Furthermore, the Receiver has inventoried and photographed all the furniture in the Heartland Fort Worth Office. The Receiver procured a quoted range for how much the furniture would sell for at auction and given the low result, the Receiver negotiated with the potential tenant to purchase the furniture, so it can remain in the office space and the Estates will not incur moving costs.

iv. Guatemala Properties

54. The Receiver understands that there may be Receivership Assets in Guatemala. She has not yet identified that property. Upon information and belief, one or more of the Heartland

Parties spent more than \$490,000 on investments in jade and land in Guatemala where jade can allegedly be mined.

v. AOS Property

55. AOS has an office at 400 Industrial Blvd., Suite 202, Mansfield, Texas. It is currently a rented space, but the Ikey Parties were unable to provide a copy of the lease. Ikey, on a December 7, 2021 visit to the AOS office, provided the Dykema attorneys with the landlord's contact information. The Receiver is currently doing further investigations regarding this lease.

vi. Graham Property

56. There is a property located in Graham, Texas, which appears to be owned by 117813 B.C. Ltd., a Receivership Party. The Receiver is exploring whether to continue to use that location. It is also being used to store some equipment and could be used to store property located in storage units. The Dykema attorneys that have visited the Graham Property diligently photographed the interiors of both the office space and the residence. A thorough list of the inventory still needs to be completed. Once the detailed inventory is completed, the Receiver will seek to dispose of any assets of value that remain on the property and have not already been seized and transported back to the Dykema Dallas office. The Receiver has not identified any liens against the Graham Property.

vii. Palo Pinto Ranch

57. There is a property located around Gordon, Texas,¹⁷ which is owned by Dallas Resources, Inc. The Receiver is exploring whether to continue to use that location or to hire a

broker to sell the property. The Receiver continues to investigate this property further but has not identified any liens against the Palo Pinto Ranch.

d. Oil and Gas Properties

- 58. The Receiver reviewed the "Heartland and Barron Petroleum Evaluation" prepared by J. Daniel Arthur, P.E. 18 attached to the Complaint as Tab 2 [ECF No. 1]. There are hundreds of wells located across multiple leases. The Receiver has spoken with Mr. Arthur and reviewed certain other publicly available information. Investors were led to believe that one or more of the Receivership Parties owned valuable oil and gas assets. The Receiver remains concerned that (a) equipment was vulnerable to theft; (b) there may be environmental liabilities; and (c) the assets are not as valuable as the investors were led.
- 59. Working with Mr. Darrell Jones,¹⁹ the Receiver entered into a Master Services Agreement ("MSA") with Contract Oil and Gas Operations LLC ("COGO"). Mr. Arthur had previous experience with COGO and/or Scott Robinowitz, the Manager of COGO. Neither the Receiver nor Mr. Jones had any prior relationship with COGO or Mr. Robinowitz.
- 60. COGO visited active and temporarily abandoned leases and equipment yards the weeks of December 6, 2021 and December 13, 2021.²⁰ The leases reviewed are operated by five different operators included in the case: Barron Energy Corp., Barron Petroleum LLC, Dodson Prairie Oil & Gas LLC, Leading Edge Energy LLC, and Panther City Energy LLC. Ultimately, COGO evaluated over 300 wells using a combination of site visits, well record review, interviews

with current and past contractors, landowners, royalty owners, and conversations with the generating geologist on the South Texas drilling project. There are 58 active wells in the portfolio and 247 temporarily abandoned wells. COGO also discovered two drilling rigs and the associated equipment. The Receivership Parties have operations in 10 Texas counties. COGO conducted field visits to 6 of those counties.²¹

- 61. COGO has not been asked to provide a reserve report or other opinion as to value.
- 62. COGO's "State of the Assets Report" does not include an opinion on asset value or marketability.
- 63. The Receiver intends to use COGO's reports as a basis for decisions related to operations, sale and/or abandonment of the oil and gas properties going forward.
- 64. Mr. Jones and Mr. Robinowitz have been able to obtain the cooperation of landowners and essentially "freeze" two drilling rigs and other equipment located in Val Verde County. The inspection has also revealed that equipment and vehicles have been moved. It has not been determined what specific equipment is missing, who moved the equipment or where the equipment is currently located. Locks providing access to certain properties had been changed without the consent of the Receiver.

e. Dallas Cowboys Tickets

65. In the late summer of 2021 (around July 22-27), one or more of the Sahota Parties entered into agreements with the Dallas Cowboys to purchase 6 "Owners Club Seat Options" with a cost of \$150,000 each. There were two down payments totaling \$180,000 for the Owners Club Seats. There are also two "Reserved Seats" where the options were \$10,000 each. The Reserved Seats have been fully paid for the 2021 season. Season tickets were also purchased for 2021. Playoff tickets are also available on a "Pay As We Play" for the Reserved Seats. The Receiver decided to purchase two playoff tickets and resold them on the exchange through the Dallas Cowboys. She is in the process of evaluating the best method for liquidating the Owner Club Seat Options and the Reserved Seats. The Owners Club tickets/licenses also provide an opportunity to purchase tickets to other events held at AT&T Stadium, *e.g.*, Big 12 Championship and PBR Rodeo.

66. The following table reflects the amount of profit made by the Receiver through the resale of the Dallas Cowboys tickets through the end of the 2021-2022 season and playoffs:

f. Jade

67. On information and belief, there are jade figures from Guatemala. The jade is stored in a facility rented by AOS and/or in the AOS office. A visual inspection of the jade has been conducted. The Receiver has no opinion as to value. The Receiver has received a reference for a potential expert in Guatemala jade figurines, whose services the Receiver may enlist should

she deem it prudent to do so. The Receiver anticipates she will seek approval of this Court to sell the jade on eBay or some similar venue.

68. Currently, the jade is being stored either at the AOS office and/or in a Cubesmart storage unit in Mansfield, Texas, which was assigned to the Receiver and which the Receiver is paying a monthly rent of \$189.00.

g. Equipment and Vehicles

- 69. The Receiver has recovered three Light Use Vehicles from the Heartland Parties—2020 Ram Crew Cab 2500 4WD, 2020 Ford F-150 4WD, and 2019 Ford F-250 4WD. All three Light Use Vehicles are being stored in a secure garage in Fort Worth, Texas. On January 19, 2022, the Receiver obtained Court approval to sell those 3 trucks and implemented protocol going forward for the disposition of other light use vehicles [ECF No. 105].
- 70. Additionally, as noted previously, the equipment that had been towed to Big Dog Towing was towed back to the Graham Property. It will remain there until it can be sold. The Receiver believes that auctioning off the oil and gas equipment and heavy use vehicles is the most efficient manner of disposing of this property and has filed a motion seeking for Court approval to dispose of the property via auction. This motion was approved January 31, 2022.
- 71. While reviewing records seized from the Graham office, the Receiver discovered three separate binders with different documentation for vehicles and equipment potentially owned by the Receivership Parties. The Receiver is still in the process of determining where all of this equipment is physically located.

F. CLAIMS HELD BY RECEIVERSHIP ESTATE

72. The Receiver received a substantial volume of bank records and bank and credit card statements relating to the prior years of the Receivership Parties. The Receiver is in the process of reviewing records recovered from Panama and law firms. Further analysis may reveal

claims and causes of action available for pursuit by the Receiver to potentially unlock value for valid claimants.

G. KNOWN CREDITORS

- 73. The Receiver is aware of "recurring charges" creditors such as internet service providers, utilities, and telephone services. The Receiver is taking steps to terminate these services, if appropriate, and determine the final amount of claims of those service providers.
- 74. The Receiver has compiled a list of known individuals who are creditors and/or investors in the Receivership Parties (or one of its investment vehicles). The Receiver has not independently verified that each person listed in these records is, in fact, a creditor or investor or the amount invested. However, according to the records located by the Receiver, there are approximately 997 investors that loaned or invested a total of approximately \$122 million to one or more of the Receivership Parties (and its related investment vehicles), exclusive of any "roll overs". The Receiver is in the process of verifying the names of the investors and the amount each has invested or otherwise advanced. She has compiled information gathered thus far, but it is lengthy and contains substantial amounts of confidential or private information, so she has not included a copy in this Report. The Receiver has not attached this list to the Report for the protection of proprietary information, as she is in receipt of recent solicitation correspondence from non-Receivership Parties seeking names of investors for the apparent purpose of solicitation for additional investment. At the Court's request she will make arrangements with the Court to either provide the information for in camera review or to have it filed under seal.
- 75. For each of the presumed investors for which contact information could be found, the Receiver has sent an informational letter, which was also placed on a website with the URL www.heartlandreceivership.com The informational letter informed the reader of the pending case

and provided an email address (heartlandreceivership@dykema.com) for submitting information requests, as well as the web address for the informational website established by the Receiver.

- 76. Since her appointment, the Receiver received over 1,000 phone calls, voicemails, or emails from investors, employees, or other interested parties. The Receiver has set up an informational website and a dedicated email address for the case. The Receiver continually updates the Heartland Receivership website with investor communications, updates "frequently asked questions," and adds key court documents.
- 77. At the beginning of the Reporting Period, one or more Receivership Parties were named as defendants in two (2) different State-Court lawsuits. Cause No. 34143, styled *John Rogers vs. Arcooil Corp. and Barron Petroleum LLC*, seeks damages for an alleged injury occurring in December 2019, and Cause No. 34433, styled *Machine Maintenance Inc. D/B/A Luby Equipment Services vs. Arcooil Corporation, Barron Petroleum, LLC, Leading Edge Energy, LLC, Roger Sahota, Manjit Sahota, Harprit Sahota, and Sunny Sahota, seeks recovery for alleged breach of contract damages for alleged failure to pay drilling invoices. Both lawsuits are pending in the 90th Judicial District Court of Young County, Texas, Judge Stephen Bristow presiding. On December 15, 2021, after contacting Receiver's counsel to obtain copies of the <i>Order Appointing Receiver*, Judge Bristow sua sponte stayed both pending litigations until further order of the Young County Court. Nevertheless, the Receiver has conferred with most of the parties (or their respective counsel) to the lawsuits in an effort to gather information sufficient to enable the Receiver to make an informed decision regarding the merits of the litigation.
- 78. The Receiver has not yet asked the Court to approve creditor claim procedures. The Receiver will request approval of creditor claim procedures only after the Receiver has confirmed that there will be assets available for distribution.

H. COURT PROCEEDINGS AND COURT FILINGS

79. The Receiver negotiated with the Receivership Entities²³ and the SEC to reach an agreement on entry of the *Agreed Preliminary Injunction Against Receivership Entities* [ECF No. 43].

80. On December 7, 2021, the Receiver filed an Application to Employ Law Practice of Darrell R. Jones, PLLC as Counsel to Receiver Effective as of December 2, 2021 [ECF No. 22] (the "DRJ Application"), and the following day the Court requested additional information regarding the necessity of Darrell R. Jones's ("Jones") employment in addition to both Romero's, as local counsel, and Dykema's [ECF No. 27]. The District Court referred this matter to United States Magistrate Judge Ray [ECF No. 62]. Additionally, on December 23, 2021, the Receiver filed an Unopposed Application to Employ BDO USA, LLP as Forensic Expert and Investigative Consultant to Receiver Effective as of December 23, 2021 [ECF No. 65] (the "BDO Application"), which was also referred to Magistrate Judge Ray. On December 13, 2021, lkey filed his Motion to Release Bank Accounts [ECF No. 47]. The District Court referred lkey's motion and briefing to United States Magistrate Judge Ray [ECF No. 59]. On January 4, 2022, Magistrate Judge Ray held a telephonic hearing on the DRJ Application, BDO Application, and Ikey's Motion to Release Bank Accounts. The Court granted both applications, authorizing the Receiver to employ and retain Jones as oil and gas transaction counsel [ECF No. 87] and authorizing the Receiver to

employ BDO as forensic expert and investigative consultant [ECF No. 88]. Judge Ray denied Ikey's *Motion to Release Bank Accounts* [ECF No. 89].

81. In accordance with 28 U.S.C. § 754, the Receiver filed a notice of receivership and copy of the SEC Application and the Receivership Order in each jurisdiction in which the Receiver suspected the Receivership Parties may own assets or could assert claims. This includes filings in the United States District Courts for the Northern, Southern, Eastern, and Western Districts of Texas; the United States District Court for the District of Colorado; the District Court for the District of Wyoming; the District Courts for the Northern, Eastern, and Central Districts of California; the District Court for the Western District of Washington; and the United States District Court for the Southern District of Indiana. Additionally, pending the Receiver's continuing investigation into potential assets, the Receiver has requested and received two separate extensions of time to file notices under 28 U.S.C. § 754 (see ECF Nos. 30 and 113, granting extensions to January 27, 2022 and January 27, 2023, respectively). The Receiver will continue to review the information which becomes available to determine whether additional notices should be filed and/or a further extension should be sought.

I. ADMINISTRATIVE ACTIONS

- 82. Change of address notices have been filed for every domestic location identified to date. Domestic mail is now being directed to the Receiver, and the Receiver has begun to receive the mail.
- 83. The Receiver has opened two bank accounts at the International Bank of Commerce. One account is for general purposes and the second will hold production payments until it is determined what amounts, if any, should be paid each month to third party holders of royalty interests (collectively, the "Receivership Accounts").

- 84. Notice has been given to purchasers of production to direct payments to the Receiver.
- 85. A website has been created to provide information to investors and creditors regarding the status of the Case: www.heartlandreceivership.com. A FAQ section has been added to the website which should answer the most common questions related to the Case. The FAQs, along with the other sections of the website allow the Receiver to quickly, inexpensively, and broadly convey information regarding the Case. The Receiver has and will continue to update the website on a rolling basis. Information regarding auctions of personal property to be sold will also be posted to the website.
- 86. An email address has been created for direct communication by investors and other parties in interest: heartlandreceivership@dykema.com. The email address was initially being monitored by attorneys at Dykema but is now primarily being monitored by a paralegal who forwards those emails that require the attention of the Receiver or a Dykema attorney.
- 87. The Receiver is in the process of either obtaining a secure area to store equipment and/or working with an auctioneer and broker to get equipment sold.

J. RECEIVER'S RECOMMENDATIONS

88. The Reporting Period covers less than one month since the Receiver's appointment. This Report is filed sixty days after the Receiver was appointed. As such, while the Receiver has recovered control of readily identifiable assets and operations and begun her diligence of identifying additional assets and liabilities, it is too soon to make a final recommendation as to how the Estates should be resolved. The Receiver has begun the process of liquidating assets, subject to this Court's approval. Accordingly, the Receiver recommends that the Case continue to allow the Receiver additional time to locate and/or monetize Receivership Assets, evaluate what

claims or causes of action can be asserted and develop a recommendation as to maximize the recovery for Investors and creditors.
