THIRD SUPPLEMENTAL RESPONSE AT REQUEST OF COURT TO RECEIVER'S FEE APPLICATION FOR SERVICES PERFORMED BETWEEN OCTOBER 1, 2024 AND DECEMBER 31, 2024, AND BRIEF IN SUPPORT [ECF NO. 676]

Deborah D. 1. On February 4, 2025, the Receiver filed the *Receiver's Fee Application for Services Performed Between October 1, 2024 and December 31, 2024, and Brief in Support* [ECF No. 676] (the "Application"), which requested, in part, Court approval, on an interim basis, and authorization of payment of fees incurred by Jones in the amount of \$1,430.00 for services performed during the Application Period as oil and gas transactional counsel to the Receiver.

I. RESPONSE

- 2. At the direction of the Court, the Receiver has reviewed Jones' invoices during the Application Period.
- 3. The Receiver has verified that Jones has expended an aggregate of 8.30 hours on this Case during the Application Period. At Jones' discounted standard hourly rate of \$325.00 per hour for all counsel, Jones' fees for the Application Period total \$1,430.00.
