NOTICE OF PROPOSED PUBLIC AUCTION OF CERTAIN OIL AND GAS ASSETS

The leases and the wells are identified on Exhibit A. The auction will be held pursuant to the procedures authorized by the Court's June 8, 2022 Order [ECF No. 215] (the "Order"). The sale of the Receivership Oil and Gas Assets will be conducted "AS IS – WHERE IS", and no warranties of any kind will be provided, except that whatever interest is owned by the Receivership Estate shall be transferred to the buyers.
