**RECEIVER'S NOTICE OF DISBURSEMENT ON OCTOBER 17, 2024**

Deborah D. Williamson, in her capacity as the Court-appointed Receiver (the “Receiver”) for the Receivership Parties (as defined in the *Order Appointing Receiver* [ECF No. 17]) and receivership estates (collectively, the “Receivership Estates”) in the above-captioned case (the “Case”), hereby files this *Notice* of distribution on October 17, 2024 pursuant to the *Order Granting Receiver, Deborah D. Williamson’s Motion for Order Approving Distribution Plan and Interim and/or Final Distribution by the Court’s July 1, 2024* [ECF No. 560] and *Order Granting Receiver’s Motion (I) to Approve Proposed Settlement with Former Counsel to Certain Heartland-Related Receivership Parties, (II) to Enter a Bar Order, and (III) to Approve Payment of Fees and Expenses of Reid Collins & TSAI LLP, Litigation Counsel to Receiver* [ECF No. 536]. Specifically,

(a) *pro rata* share of \$5,000,000.00 to Allowed Class 4a and 4b Claimants who provided a completed and signed W-9 on or before October 14, 2024, and

(b) *pro rata* share of \$9,375,000 in Net Settlement Proceeds to Allowed Class 4a Claimants who provided a completed and signed W-9 on or before October 14, 2024.

On September 11, 2024, the Receiver made a distribution to Allowed Class 4a and 4b Claimants who provided a completed and signed W-9 on or before August 29, 2024 (the “September Distribution”).<sup>1</sup> The October 17, 2024 distribution was made to Allowed Class 4a and 4b Claimants who did not receive a distribution in September and whose completed and signed W-9 was received on or before October 14, 2024. Claimants who received the September Distribution did not receive a distribution in October.
