The county grant for the high water/ bush truck is still on order. Have not been able to get a chassis from Ford Motor Co. The brush truck has no scheduled time of arrival. It could take as long as a year.

The portable radios are in but the mobil radios have not been received yet.

Equipment:

The Chief met with Siddons-Martin representative about the new tanker that is on order. It is scheduled to be ready in May but could be delayed up to three months.

The display panel on Engine #64 is going out. Siddons-Martin is getting a price for repairs which will be approximately \$2,800.00

The Chief wants to look into replacing the chassis on the 2008 Chevrolet Combination 63 The Chief will take it to the shop to find out if there is anything wrong with the

motor. Treasury, Mike Morrison made the motion for it to be taken to the shop. Secretary Joe Clark seconded the motion. Motion carried.

The wheel seal on Engine 61 has been replaced.

Station Report:

The air conditioner is working at the Rescue Center.

A high pressure natural gas line was cut at the building sight of the new fire station. This line was not on any of the existing maps. The leak was fixed by Center Point Energy.

A discussion was had about the recurring problems with internet and phone service. Chief is to look into Spectrum service and report back to the Board.
