POLICIES

BOOKINGS:

To secure a date, a signed contract is required with a 40% deposit due at the time of signing. The deposit is non-refundable and non-transferable. Please be advised, dates and scheduled makeup times will only be reserved when a signed contract and deposit are received.

CONSULTATIONS:

Consultations are available for brides/bat mitzvahs, as well as, included but not limited to, bridesmaids, mothers of the bride and groom, grandmothers, extended family members, etc.

REFUSAL OF SERVICE:

We refuse the right to service any client(s) disrespectful to anyone assisting Staci Mara Artistry. Leaving the "Glam Seat" is prohibited, as there may be time restrictions. Unless agreed upon by a member of Staci Mara Artistry, a client leaving the "Glam Seat" will result in immediate termination of service. Just as we treat our clients with respect, we expect the same.

DELAYS:

A late fee of \$25.00 will be charged for every 30 minutes of delay when a client is late for the scheduled time, or if scheduled makeup application exceeds allotted time because of client delays.

SATISFACTION GUARANTEED:

Makeup will be completed to client's satisfaction, but is not to exceed allotted makeup time. Ample time is given for each makeup upon booking. Acceptance of completed makeup application by client is acknowledgement by client that makeup is done to his / her satisfaction.

SERVICE LOCATION AND REQUIREMENTS:

Location of service for the day-of-event will be at the discretion of the client, but there are certain requirements the makeup artist needs in order to complete the makeup applications. A "set up" table / work area needs to be made available for the makeup artist at said location. Ample lighting, whether by means of natural light or by lamps, is necessary for services to be performed properly.

REFUNDS:

No refunds will be given for members of the party who missed their appointment on the day of the event. The person(s) signing this contract will be held responsible for the balances from any members of the party who fail to provide payment.

LIABILITY:

All brushes and makeup products are kept sanitary and are sanitized between every makeup application. Makeup products used are hypoallergenic. Any skin condition should be reported by the clients to the makeup artist prior to application and, if need be, a sample test of makeup may be performed on the skin to test reaction. Client(s) agree to release the makeup artist from liability for any skin complications due to allergic reactions.

PAYMENT: The final balance is due on or before the day of the event as one payment, before the makeup artist departs - no exceptions. The person(s) responsible for the entire balance of payment is the person(s) who has signed the booking contract. ****NOTE:** if payment is made on day of application, Staci Mara Artistry will only accept cash or Venmo.

CANCELLATION POLICY: Cancellations must be made (14) days prior to your reserved date or you will be responsible for the amount of services agreed upon in this contract.

ARE THERE ANY PREPARATIONS NEEDED FOR GETTING MY MAKEUP SERVICE DONE?

Work Station: Please have tables and stools ready with natural lighting to perform the makeup services.

Outfit: Wear a buttoned down shirt or anything you don't have to pull over your head.

Face: Should be cleansed with a daily skincare system. Please state any allergies pertaining to any makeup products to your stylist before the service. Facial treatment is not recommended less than 7 days before the event.

DO I NEED TO PUT ON ANY SKIN PRODUCTS BEFORE RECEIVING THE SERVICE?

For facial cleansing the night before, one just needs to apply toner after washing their face. Following this procedure, will help facilitate the artists to apply makeup primer and makeup setting spray during the next day more efficiently.
