If payments are not paid for 3 consecutive months, you understand that your account will be permanently frozen and your remaining balance will be sent to a collections agency to finalize terms for the **FULL** amount of the remaining contract.

## **OTHER GUIDELINES**

Jobe & Sons reserves the right to cancel our gold membership contract for any reason. Should we cancel a contract, on an annual plan- we will give back the remainder of an annual plan minus the calculated months that have been used. For monthly payments, if Jobe & Sons cancels the contract, payments will be stopped minus the last made payment. If monthly payments are unable to be processed due to canceled card information- we will reach out to collect proper information to ensure your benefits stay up to date, If we are unable to continue processing payments for the monthly rate, we will cancel the contract and a bill for the full amount of the remainder of the 12 month period will be sent with late fees included. If late bill is not paid within 30 days of cancelation, Jobe & Sons plumbing reserves the right to send said bill to collections as needed in the full amount of all late fees plus months remaining.

**Only one benefit may be applied at a time. As a gold member, you enjoy a 15% discount- as such we do not stack discounts, regardless of what they are.
