I ACKNOWLEDGE THAT THIS GALLERY MAY BE SUBJECT TO THEFTS, BREAK-IN AND OTHER ILLEGAL ACTS THAT MAY RESULT IN LOSS OF PROPERTY AND/OR OTHER FINANCIAL LOSS. The risks may include, but are not limited to, those caused by burglary, shoplifting, robbery, weather, act of god, or other natural disaster, or the initial condition of member's merchandise.
