It is hereby the policy of the Parma City Council, once a device or piece of equipment has been determined to be of no further use to the City of Parma, it may be donated, sold or destroyed based on the recommendation of the department head and in agreement with the Mayor.

If the asset has a City of Parma Asset Tag assigned or attached to it, the property shall be removed from the asset log and a list will be generated with the disposal or property to be turned over to the auditor on an annual basis during the annual audit.

If the asset is leased, it shall be returned to the lessor for credit if possible.

If the asset is sold, proceeds shall be turned over to the city treasury immediately.

If the asset value is under \$100 and does not have an asset tag, it may be disposed of any way deemed fit by the department head.

If the asset has an assumed value over \$100 in its current condition a surplus resolution shall be created and the City Council shall have the sole authority to dispose of the asset in accordance with Idaho State Code and the City of Parma policies at the time.

The Parma Library Board notified the City of Parma of their desire to surplus the above-listed equipment via the Library Director on October 20th, 2025.

This resolution shall take effect and be in full force from its passage and approval.
