The Golden Retriever puppy is available for a total purchase price of \$1,200. A non-refundable deposit of \$500 is required to reserve the puppy, with the remaining balance of \$700 due upon transfer of ownership.

A pet PUPPY is defined here to be a "*Golden Retriever*" puppy which is in good health at the time of sale and embodies the characteristics of the Golden Retriever breed. This puppy is purebred and is AKC registered.

The parents of this PUPPY have had x-rays to establish that they are free of Hip and Elbow dysplasia. They also have Certifications of Eye, Cardiac and Thyroid.

The BREEDER agrees to take back this puppy if on, or before 24 months the puppy is not free of hip and elbow dysplasia. Shipping costs are BUYERS' responsibility.

BUYER has 5 days from date of possession to return puppy at buyer's costs for reasons except illness or injury due to shipping.

Golden Retrievers are not working dogs, injuries due to pulling sleds or any other form of work will be the responsibility of the BUYER.

This PUPPY is registered with limited Registration, which will prohibit breeding and registering offspring. (The BUYER agrees this female/male PUPPY is to be spayed/neutered at the appropriate age, and veterinarian confirmation of this procedure must be supplied to the BREEDER.)

The BREEDER does not assume any liability for any injury to said puppy after delivery. In the event BUYER chooses to utilize shipping as a means of delivery any injuries or sicknesses contracted in shipping are the sole responsibility of the BUYER. Airlines require BUYER to have veterinarian check puppy prior to shipping for health, this will be at BUYERS cost. BUYER agrees to pay for shipping costs including puppy crate.

The BUYER agrees to have this puppy examined by a veterinarian within 72 hours of Delivery if the BUYER thinks the puppy has some kind of illness or injury prior to taking Possession.

If the puppy is found to be other than healthy by the BUYER'S veterinarian, it shall be returned to the BREEDER immediately, and the purchase price will be refunded. Deadline for this refund is immediate.

All appropriate shots for the PUPPY'S age have been given, and a record of this vaccination history is supplied.

The BUYER agrees to maintain the puppy's health in good condition, and to provide yearly examinations, vaccinations and any other usual procedures necessary to ensure good health.

The BREEDER has done everything possible to produce healthy sound puppies both by breeding only dogs (parents) that are certified free of hip and elbow dysplasia, eyes, cardiac and thyroid and by raising the puppies in the best way possible regarding diet, exercise, socialization and veterinary care.

There are many factors that can influence growth and development, such as diet, exercise, weight gain, etc. The BUYER assumes the responsibility to carry on with the appropriate vaccinations, exercise and feeding schedule. The BREEDER can offer no further guarantees once the care of the puppy is no longer under their control.

The BUYER agrees that neither he/she nor the BUYER'S estate/executors may sell this PUPPY or transfer ownership of this PUPPY without the BREEDER'S knowledge and written consent.

The BUYER hereby agrees that if at any time the Buyer cannot take proper care of the puppy, the BUYER must contact the BREEDER, and the BREEDER will have the first choice either

- : (a) take the PUPPY back, or
- (b) Assist the BUYER in finding a suitable home for the PUPPY.

The BUYER agrees to notify BREEDER of any changes of address during the PUPPY'S Lifetime.

The BUYER agrees to provide a suitable fenced area for this PUPPY.

The BREEDER neither makes nor implies any warranties or guarantees, express or implied, other than those written in the agreement including, without limitation, the warranties of merchantability and fitness. This document constitutes the entire agreement between the Breeder and Buyer with respect to this sale. The Buyer's signature below indicates that he/she has read, agrees and does understands all the conditions of the Sales Agreement and Contract of Sale.
