- 2. A \$50.00 per hour cleaning fee will be charged in the event the vehicle is not returned in the same condition as received. Excessively dirty vehicles are subject to a \$150.00 charge. Damages to the vehicle are the responsibility of the signatory.
- 3. Passengers seated in the front are required to wear a seat belt at all times.
- 4. Children under 6 years old or less than 40 lbs. must use a child seat.
- 5. The signatory will be charged \$20.00 plus the price of refueling in the event the vehicle is not returned with the same amount of gas when picked up.
