

PAWNEE SPORTSMENS CENTER RIFLE/PISTOL RANGE RULES

1. Rifle and Pistol shooting hours for members who are certified Range Officers are Sunrise to Sunset any day of the week. Non-members and members who are not certified Range Officers are limited to PSC's public hours. Access to the cowboy action range, trap and skeet ranges are limited to our "open to the public hours" for both Members and Non-members.
2. Alcohol is not allowed in any of the shooting areas, intoxication and/or disruptive behavior is grounds for dismissal and cancellation of shooting privileges.
3. All rifle/pistol shooting is to be done under the supervision of a PSC Certified Range Officer. Range Officers will either be PSC staff or PSC Members who have paid their annual dues and passed the Range Officer Test.
4. The muzzles of all firearms are to be pointed in a safe direction at all times. Always treat a firearm as if it were loaded.
5. All barrels are to be checked for obstructions before firing. All firearms are to be in good working condition.
6. The actions of all uncased firearms are to be open except when on the firing line and ready to fire. Loaded pistols may be taken away from the firing line only when completely cased or holstered. All firearms should be cased or holstered except when on the firing line.
7. All firearms are to be immediately unloaded upon the "cease fire" command, **no exceptions**. Firearms are not to be handled during any cease-fire, this includes handling to adjust sites, cleaning, storing of the firearm for transport or any other purposes.
8. All shooters under the age of 18 are to be accompanied by an adult. An experienced shooter or range officer should supervise inexperienced shooters.
9. Loud and abusive language, horseplay or disruptive conduct will not be permitted.
10. When finished shooting, all shooters will clean up the range area of all targets and trash.
11. Destroying or damaging any PSC property will be grounds for immediate dismissal.
12. Shooting of wildlife is not permitted on the property. The only exceptions are in the designated hunting areas and only with prior permission.
13. Rifles or pistols are not allowed on the shotgun ranges.
14. Shotgun slugs may be shot on rifle or pistol range. Bird-shot type shotgun loads may not be shot on the rifle or pistol range. Black Powder rifles/pistols are allowed on the rifle and pistol ranges.
15. There shall not be any loading of or loaded firearms behind any firing line.
16. All vehicles must stay on roads or in designated parking areas.
17. The entrance gate is to be kept locked except during organized events or open to the public hours.
18. The only allowable targets for use on the range are removable targets either brought by you or purchased from the pro-shop. Only targets that do not cause ricochets are acceptable. No targets are to be placed on or shot from the ground. Glass targets or any target that shatters on impact are forbidden.
19. All dogs are to be kept on a leash or in your vehicle.
20. Children must be supervised at all times.
21. Eye and Ear protection are required at all times while on or near the firing line.
22. All standard calibers less than .50 are permitted. Those wanting to shoot .50 caliber need pre-approval. Armor piercing, tracer, or incendiary rounds of any kind are prohibited.
23. No one is allowed downrange on the Long (400-1000 yd) Range for any reason; PSC staff will paint the steel targets as needed.
24. The Long Range is a PRE-SET STEEL TARGET ONLY area. Use of any other targets on this specific range is prohibited. Steel targets are placed at 100-yard increments from 400 to 1000 yds. Targets painted Orange are for use by extra heavy calibers: .338 Lapua, & .50 (pending pre-approval).
25. **ALL SHOOTERS** need to be familiar with and follow the above listed rules and operation guidelines. **SAFETY** is the responsibility of all PSC visitors, members, and employees.
