## **Tracy Rampage - Parents Code of Conduct**

- I will be responsible for my behavior as well as for the behavior of those who attend the game/practices as my guest.
- I hereby pledge to provide positive support, care, and encouragement for my child participating in youth sports by following this Parent's Code of Conduct.
- I will demonstrate and encourage good sportsmanship by supporting all players, coaches, and officials at every game, practice or event.
- I will place the emotional and physical well-being of my child ahead of a personal desire to win.
- I will be in control of my emotions always
- I will remain in the spectator area during games/practices. Parents are not allowed on the fields.
- I will require that my child's coach be trained in the responsibilities of being a NCYFC coach and that the coach upholds the Coach's Code of Conduct.
- I will insist that my child play in a safe and healthy environment.
- I will support coaches and officials working with my child, in order to encourage a positive and enjoyable experience for all.
- I will not advise the coach on how to do their job.
- I will demand a sports environment for my child that is free of drugs, tobacco, and alcohol and will refrain from their use at all practices, home and/or away games including in the parking lot.
- I will remember that the game is for our youth NOT ADULTS and that participation in youth sports is a privilege, not a right.
- I will show respect for all participants, coaches and board members at all times.
- I will do my very best to make youth sports fun for my child
- I will not coach my child during games or practice.
- I will ask my child to treat other players, coaches, fans, and officials with respect regardless of race, sex, creed or ability.
- I will not make insulting comments to players, parents, officials, or coaches of either team.
- I promise to help my child enjoy the youth sports experience by being a respectable fan
- I will require that my child's coach be trained in the responsibilities of being a youth sport coach and that the coach upholds the Coaches Code of Ethics.
- I understand the 48-Hour Rule: All communication with the coach will not take place within a 48-hour window that immediately follows a game.
  - o Email should then be sent to Team Coordinator for a meeting with the coach
  - o The Coordinator will coordinate a time before or after practice
  - o Meeting will include coach, parent and at least one other coach or board member
  - o All communication should be about **your child only**.

## **Parents Mandatory Obligations**

I understand that I am required to complete the following for my child to participate.

- \$100 Raffle Fundraiser All money from raffle must be turned in to receive uniform
- Sign up and complete 8 Volunteer Hours (4 shifts)
- Fees
  - o Absolutely NO REFUNDS (league rule)
  - All fees must be paid prior to payment deadlines to receive uniform and equipment
